**Subject: RECRUITMENT OF RESEARCH ASSOCIATES-I IN CENTRAL POLLUTION CONTROL BOARD.**

Sir/ Madam,


With reference to your application for Research Associates-I on the basis of performance in the interview held on 28<sup>th</sup> June & 29<sup>th</sup> June 2017, I am directed to offer you for the post of Research Associates-I Under project in the Central Pollution Control Board, on the following terms and conditions.

- (i) The fellowship will be available initially for the period up to 31.03.2018 which is likely to be extended on year to year basis.
- (ii) You will be paid monthly stipend of Rs. 36000/- Per Month.
- (iii) You will be entitled for HRA as per rules. For this purpose, the stipend admissible to you will be treated as the basic pay.
- (iv) You will not be entitled to DA, CCA, Bonus and LTC. You will not be eligible to be a member of the Contributory Provident Fund.
- (v) You will not be entitled to any traveling allowance for joining duty as Research Associates-I.
- (vi) You will be required to serve for a minimum period up to 31.03.2018.
- (vii) The fellowship may be terminated at any time with a notice period of one month by either side.
- (viii) You will be entitled for leave as per rules applicable to Research Associates-I.
- (ix) The offer of Fellowship will not confer any right on you for regular appointment in Central Pollution Control Board. The period of service rendered as Research Associates-I will not count for the purpose of seniority or for counting of length of the service benefit in case of your appointment at a later date on regular basis at any post in the Central Pollution Control Board.
- (x) You will not be entitled to any retirements benefits for the period of service rendered as Research Associates-I in Central Pollution Control Board.

- (xi) You shall take an oath or make a solemn affirmation of allegiance to the constitution of India and also take oath of secrecy.
- v) The data/information generated during the tenure of the appointment shall be the property of Central Board and in no circumstances; he /she shall be allowed to publish the data/information,
  - w) All patents arising out of the investigation, if any shall have proprietary right of central Board and no project fellow shall have right to publish/reproduce in any form.
  - x) At the time of relieving he/she has to submit all information/data etc. to the Central Board and a certificate that he/she will not publish or use/misuse any data at any point of time.
- (xii) If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material information, you will be liable to be removed from Research Fellowship and to such other action as the Board may deem fit.
- (xiii) You are required to submit the following documents (which can downloaded from CPCB website i.e. [www.cpcb.nic.in](http://www.cpcb.nic.in)) before or at the time of joining.
- (a) A medical certificate of fitness in the prescribed form (Specimen Attached) by a Civil Surgeon or a District Medical Officer or a Medical Officer of equivalent status of Govt. Hospital.
  - (b) Character Certificate by two different Gazetted Officers.
  - (c) Attestation forms duly filled for police verification.
  - (d) Declaration affirming that you have not been prosecuted for any criminal offence nor there is any criminal case pending against you in any court of law.
  - (e) Declaration regarding marriage.
  - (f) Faithfulness to the constitution of India.
  - (g) Indian Official Secret Act.
- (xiv) If you accept the offer of Research Associates-I with the aforesaid terms and conditions, you should intimate your acceptance of the offer within 15 days from the date of issue of this letter and should report to **Incharge ----- at Head Office Delhi**, for duty, after being declared medically fit within 30 days of issue of this letter. In case you fail to report for duty within the specified date, it will be assumed that you are not interested to take up the Fellowship offered to you and the offer of fellowship will be treated as cancelled without any further information.
