**General Conditions: -**

- (i) Only Indian national need to apply.
- (ii) The number of post likely to increase or decrease as per the requirement.
- (iii) The above positions are purely temporary and co-terminus with the project. The service of the selected candidates will stand terminated automatically after the expiry of the project or completion of period mentioned in the offer of appointment whichever is earlier. The period can be extended further by the Competent Authority as per requirement annually. He/She will not have any right to claim for regularization or absorption whatsoever in regular vacancies of the Central Pollution Control Board(CPCB).
- (iv) TA/DA will not be admissible for attending the interview.
- (v) Recruitment will be made through INTERVIEW, however, relevant documents/mark-sheet including experience certificate would be verified and screening would be made. Candidates would be selected on the basis of merit prescribed for the post applied for.
- (vi) The Board reserves the right not to fill up the post, if so decides, no correspondence/representation will be entertained in regard to the walk in interview and /or selection.
- (vii) The eligible /qualified candidates can "WALK IN FOR INTERVIEW" at the venue i.e. **Central Pollution Control Board, Parivesh Bhawan, East Arjun Nagar, Near Karkardooma Court, Delhi-110032**. While appearing for interview, the candidates are required to submit an **APPLICATION FORM** (as per format) alongwith self-attested **one set photocopies** of all degree/Academic Qualification certificates (**10<sup>th</sup> Certificate is mandatory for Date of Birth**)/Marksheets/ Experience Certificate (**Certificate from Employer**) etc. should be attached with this form. Candidates will be required to produce **Marksheets/Certificates/Testimonials in original** at the time of interview failing which applicant will not be allowed to appear for interview. Registration shall close at scheduled time therefore candidates are advised to reach at venue 15 minutes before the scheduled time.
- (viii) Candidates shall clearly indicate the name of post i.e. RA-I, II & III for which they are appearing for interview. Candidates can appear for more than one posts. However, the same should be indicated in prescribed Application format.
