DIRECTION UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, M/s N. K. Laminates (P) Ltd., Vill- Dedupur, Post- Sambhalpur, Kanpur, Uttar Pradesh (hereafter referred to as the 'Unit') is a polluting industry engaged in processing of Kutch & Kattha with consented capacity of 180Kg/day; and

WHEREAS, the unit had informed that their unit fall under SSI and is engaged in Kattha and Cutch manufacturing. The water discharge of the unit is less than 03 KL and unit is not in the list of grossly polluting industries (GPIs) issued by UPPCB.

WHEREAS, CPCB issued revoke direction dated 25.07.2016 to exempt the unit from installation of the OCESMS; and

WHEREAS, the unit was jointly inspected on 23rd May, 2017 by the officials of CPCB to verify the implementation of action plan for water conservation & zero liquid discharge; and

WHEREAS, CPCB issued show cause notice dated 23.08.2017; and

WHEREAS, the unit's reply vide letter dated 14-09-2017 was examined and following observation are made:

1. The unit has installed electromagnetic flow meter on 05.09.2017 at inlet of bore well and outlet of ETP. Both meters were made operational on 06.09.2017. The water consumption record is being maintained.
2. Water consumption data for 15 days and ETP log book provided.
3. The unit is member of M/s Uttar Pradesh Waste Management Project, A division of Ramky Enviro Engineers Ltd., Plot No. 672, on NH-2, Sikandra road, Village Kumbhi, Tehsil Akbarpur, Kanpur-Dehat-209101, Uttar Pradesh for disposal of solid waste since 10.09.2012. The membership no. is UPWMP-KNP-HZW-CHW-TSDF.
4. All the treated water is being recycled in filter cloth and floor washing.
5. The unit has upgraded ETP and also improved dosing of chemicals, de sedimentation of tanks and cleaning of interconnecting pipes. The analysis report dated 24.08.2017 shows all parameters are within norms.

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, show cause notice dated 23.08.2017 issued to the unit is hereby revoked and the unit **M/s N. K. Laminates (P) Ltd. Vill- Dedupur, Post- Sambhalpur, Kanpur, Uttar Pradesh** is directed to comply with the following direction:


1. The Unit shall operate ETP properly so as to ensure compliance with the effluent discharge norms notified under Environment (Protection) Act, 1986. At any stage, if the treated effluent does not meet notified discharge standards the unit shall close down manufacturing operations immediately and report to CPCB.
2. The unit shall maintain the ZLD condition as per the consent issued by UPPCB.

In case of default in compliance with the above directions, CPCB will be constrained to initiate action without any further notice, in accordance with the provisions of the Environment (Protection) Act, 1986.
