**Directions under Section 5 of the Environment (Protection) Act, 1986 Revoke**

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**WHEREAS**, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Water and Air, having potential to threat to cause adverse effects on the water and air quality; and

**WHEREAS**, M/s Everest Tanning Industry, 97A, Wajidpur, Jajmau, Kanpur, UP (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 24.03.2017 to verify the compliance status; and

**WHEREAS**, CPCB issued closure direction dated June 21, 2017 under Section 5 of Environment (Protection) Act, 1986 to the unit; and

**WHEREAS**, unit's reply vide letter dated 21.11.2017 was examined & following observation are made:

1. The unit submitted the details of registration of the OCEMS with the CPCB portal and provided the connectivity with CPCB server.
2. The unit has submitted copy of consents under the Water & Air Acts with validity till 31.12.2017.
3. The unit has submitted self-certificate regarding stoppage of all operations w.e.f. 01.07.2017 & provided the undertaking on the affidavit for close down the unit immediately till full compliance.
4. The unit has installed the flow meter on the fresh water extraction point.

**AND WHEREAS**, CPCB Constituted a Three-Member Committee vide office order dated 27/09/2017 having representative from CPCB, MoEF & CC and NMCG for examination and recommendation for revocation of the closure direction issued by CPCB; and

**WHEREAS,** The Three Member Committee in its meeting held on 30/11/17 examined the reply dated, 21.11.2017 and recommended the Unit to resume operation with the following condition

1. The unit shall resume its operation only after obtaining valid consent from the concerned State Pollution Control Board.
2. The unit shall submit the schedule of discharge in CETP to the concern State Pollution Control Board and Central Pollution Control Board.

**AND NOW, THEREFORE,** in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the closure direction dated June 21, 2017 is hereby revoked and the unit is directed to comply with the following.


1. The unit shall ensure proper operation of PETP so as to achieve the prescribed standards and continuous transmission of data to CPCB.
2. The unit shall submit the schedule of discharge in CETP to the concern State Pollution Control Board and Central Pollution Control Board
3. The unit shall submit treated effluent analysis report from lab recognised under the Environment (Protection) Act, 1986, to CPCB under 30 days of resumption of operation.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further stringent action against the unit (M/s Everest Tanning Industry, 97A, Wajidpur, Jajmau, Kanpur, UP), in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.
