- i. Minimum 06 years practicing experience exclusively dealing with the cases in High Courts and National Green Tribunal independently.
- ii. Preference will be given to those advocates conducting cases on Environmental Laws in the High Court's & National Green Tribunal (Advocate with science background is preferred)


District Courts and Central Administrative Tribunal in Central Zone

- i. Minimum 04 years practicing experience exclusively dealing with the cases in District Courts and Central Administrative Tribunal independently
- ii. Preference will be given to those advocates conducting cases on Environmental Laws in the High Court's & National Green Tribunal (Advocate with science background is preferred)
