
**Terms & Conditions:**

1. Sealed quotations should be dropped in the quotation box kept at reception (Ground Floor) of Parivesh Bhawan, CPCB on or before 25.10.2017 by 3.00 pm.
2. The quotation has to be accompanied by an EMD of Rs.2007/- (Rs. Two Thousand Seven only) as Demand Draft in favour of Central Pollution Control Board, Delhi. The EMD of unsuccessful bidders shall be returned after award of work to successful bidder. The EMD of successful bidder shall be deposited in CPCB account and will be refunded after satisfactory completion of work. No interest shall be paid on it.
3. The terms & conditions and taxes etc. should be clearly mentioned in the quotation.
4. The quotations shall be valid for 03 months from the date of their opening.
5. The rates quoted should be as per our specification.
6. Payment will be made after satisfactory completion of work and testing of earth resistance as per standard norms. No advance payment will be made.

7. The bidders have to submit copy of valid registration certificate of CPWD/MES or any other Govt. Organisation, PAN Card, GST no., alongwith the bid.
8. 10% security will be deducted/retained from the bill for defect liability period of 06 months.
9. The defect if any, found within 06 months after completion of the work should be rectified by the quotee at his own cost.
10. The work should be completed within 01 month from the date of issue of work order.
11. Income Tax shall be deducted at source.
12. The work shall be carried out strictly according to CPWD specifications for electrical work.
13. It may be noted that mere quoting the lowest rates will not entitle any firm to get the work order.
14. The over writing and corrections, if any should be counter signed.
15. The Chairman, Central Pollution Control Board reserves the right to cancel any or all the quotations without assigning any reasons thereof.
