Minutes of Meeting

Subject: Minutes of Meeting on Analysis of SMS Report and Offline Industry Data (15th July to 15th August 2017) held on 11/09/2017 at 2nd Floor Conference Hall.

A meeting was held on 11th Sept 2017 on above mentioned subject and chaired by Chairman, CPCB at 2nd Floor Conference Hall. It was attended by Divisional Heads and Senior officers of IPC-I, IPC-II, IPC-III, IPC-IV, IPC-VI and WQM-II.

1. Divisional Head, IPC VI, Sh. P.K.Gupta presented status of action taken on Inspection Reports (IR) received from Regional Directorates. The inspections were carried out on the basis of SMS alerts and Offline industries lists. He has presented the entire scenario since beginning of this activity.

Discussions were held and following major directions were issued by CCB CPCB:-

1. Regional Directorate wise break up of all 42 complying industries to be submitted by IPC-VI by 11.09.17.
2. Based on SMS and Offline list data (from Oct 2016 to Sept 2017) all Divisional Heads were directed to provide details of 71 non-complying units and wherever Show Cause Notices (SCN) are issued, details of Action Taken Report with follow up action to be submitted. IPC VI to compile and place the information to MS and CCB.

3. Each Division will provide break up of 48 Under Process Inspection Reports mentioning the oldest Inspection Report pending for processing with reasons. It was directed that there should not be delay in processing Inspection Reports by the Division.
4. It was also directed that IPC-VI will pursue Regional Directorates to complete pending Inspection Reports by 20th Sept 2017.
5. Inspections in Power Plants of Delhi NCR region have to be completed by 25th Sept, 2017 for which IPC II and Air Lab are conducting monitoring. It was proposed to engage third party for such monitoring and agreed.
6. Regarding Badarpur TPP Fly Ash disposal site inspection, it was directed that CPCB team should also visit along with DPCC team to regulate the disposal of flyash.
7. Member Secretary, CPCB Sh. A Sudhakar communicated that "CPCB policy for Real Time Effluent and Emission Data Collection" has been uploaded at CPCB website and this should be followed by every industry especially during shifting from one Technology Provider to another Technology Provider.
8. Sh. Aditya Sharma, Sc'D', IT, communicated that the CPCB Real Time Data Policy has been placed on CPCB website. It includes data policy for SPCB, Technology Providers and Industry.
9. CCB directed IT Division to present the Data Policy in the SPCBs Review meeting to be held on 18th Sept 2017. It was also directed to call all Industry Associations meeting like CII, FICCI etc. to write letters to various involved agencies to publicize the policy.
