## **General Conditions:-**

- (i) Only Indian National need to apply.
- (ii) The number of post likely to increase or decrease as per the requirement.
- (iii) The above position is purely temporary and co-terminus with the project. The service of the selected candidates will stand terminated automatically after the expiry of the project or completion of period mentioned in the offer of appointment whichever is earlier. The period can be extended further by the Competent Authority as per requirement annually. He /She will not-have any right to claim for regularization or absorption whatsoever in regular vacancies of the Central Pollution Control Board (CPCB).
- (iv) Age not exceeding 40 years for RA I, II, III, 32 years for SRFs and 28 years for JRFs as on date of interview (upper age limit relaxable upto 5 years in case of candidates belonging to SC/ST, and female candidates, 3 years in the case of OBC category). Those who are belong to SC/ST/OBC are required to produce the Original Caste Certificate issued by the competent authority
- (v) TA/DA will not be admissible for attending the interview.
- (vi) Recruitment will be made through INTERVIEW, however, relevant documents/mark-sheet including experience certificate would be verified and screening would be made. Candidates would be selected on the basis of CPCB norms prescribed for the post applied for.
- (vii) The Board reserves the right not to fill up the post, if so decides, no correspondence/representation will be entertained in regard to the walk in interview and /or selection.
- (viii) Candidates should make one day stay arrangement at Lucknow as interview may continue on next day depending on the number of candidates.
- The eligible /qualified candidates can "WALK IN FOR INTERVIEW" at the venue, on date and time as mentioned below. While appearing for interview, the candidates are required to submit an APPLICATION FORM duly signed and pasted with a recent color passport size photograph in aforesaid mentioned performa and duly self-attested one set photocopies of all degree/Academic Registration shall close at scheduled time therefore candidates are advised to reach at venue 15 minutes before the scheduled time.
