- b. i) Possessing Master's Degree in Science or equivalent, or Bachelor's Degree in Engineering, Technology or equivalent.
- ii) Experience in different aspects of Environmental Management, Pollution Control such as Ambient and Source Specific Monitoring, Analysis and Characterization of Wastes, Development of Standards, Environmental Impact Assessment, Pollution related Research and Development and design and operation of Pollution Control Systems.

- ii) Having atleast 5 years of regular service in the post in the scale of Rs. 12,000-375-16,500/- (Pre-revised) or equivalent; and
- b. i) Possessing Master's Degree in Science or equivalent, or Bachelor's Degree in Engineering, Technology or equivalent.
- ii) Experience in different aspects of Environmental Management, Pollution Control such as Ambient and Source Specific Monitoring, Analysis and Characterization of Wastes, Development of Standards, Environmental Impact Assessment, Pollution related Research and Development and design and operation of Pollution Control Systems.
