The Principal Chief Conservator of Forest, Lucknow be informed to constitute a team to visit Gola, District Lakhimpur Kheri and evaluate the damage caused to the forest land due to polluted water of Bajaj Sugar Mill, Gola. The team so constituted shall assess the total area of forest land granted on lease to Bajaj Sugar Mill, Gola and submit report:

- (i) Whether the terms and conditions of lease deed have been violated?
- (ii) Whether the polluted water of Bajaj Sugar Mill has spread over the forest land beyond the leased area? In case yes, then the extent of area which is suffering because of damage caused by the polluted water of Bajaj Sugar Mill?

Let this order be communicated by the Nodal Officer to the UP Pollution Control Board immediately for follow up action. The aforesaid report be forwarded to the Monitoring Committee, through the Secretary, Eastern UP Rivers and Water Reservoirs Monitoring Committee, Lucknow alongwith the copy of lease deed granted to Bajaj Sugar Mill, Gola and extensions granted from time to time.

He shall also provide a list of the names of head of families including total members of the families, who suffer from polluted water of Masoda Sugar Mill, beginning from village Masoda Khanpur to river Tamsa, as far as possible within two weeks.

The District Magistrate shall also do the needful to find out the persons suffering from various diseases on account of contaminated water of Masoda Sugar Mill and Yes Paper Mill in the affected areas of villages. It shall be open to the District Magistrate to constitute a team of Medical Officers and revenue authorities to submit report in respect of above within two weeks from the date of communication of this order by the Nodal Officer.
