

Minutes of Review Meeting with Public Agencies on Delhi NCR Air Quality on Ground Actions & Preparedness for ASEAN Summit

January 12, 2018 at CPCB, Delhi

Review meeting to discuss actions taken towards controlling air polluting activities in Delhi & NCR and preparedness for upcoming ASEAN summit was held at Parivesh Bhavan, CPCB, Delhi on January 12, 2018. The meeting was chaired by the Chairman, CPCB. List of participants is placed at Annexure-I.

Chairman, CPCB welcomed the participants and emphasized on need for proactive actions by concerned implementing agencies in maintaining air quality within acceptable limits during ASEAN - India Commemorative Summit to be held in Delhi during January 19 – 30, 2018.

The officials from municipal bodies & DPCC, briefed various measures taken for air pollution control including action on field feedbacks from CPCB teams, deployment of 35 Marshals for vigilance & control of open burning, dust re-suspension, etc. display of air quality data at 50 locations (100 by March 2018), mechanized sweeping by EDMC (04), SDMC (15), North DMC (05), regular water sprinkling at Anand Vihar and issuing challans against open dumping & burning of waste. Delhi Police informed that movement of vehicles will be restricted during 25th to 27th January. The information on traffic diversions and congestion for twelve corridors will be displayed via Google map.

The officials from UPPCB and HSPCB, informed that conversion of conventional brick kilns to zig-zac is under process and expected to be completed by 31st March, challans are being issued against open dumping & burning and action taken reports are being submitted to CPCB.

After detailed deliberation, following actions were agreed upon,

1. Concerned implementing agencies (DPCC, MCDs, Traffic Police, etc.) to remain on high alert during the ASEAN-India Commemorative Summit and ensure strict vigilance
2. CPCB and DPCC field feedback teams to conduct extensive field visits starting January 16-30, 2018
3. State Boards to keep a check on air pollution from industrial units by conducting joint monitoring exercise and penal actions, if required.
4. Extensive field deployment in major neighbouring towns of Ghaziabad, Noida, Faridabad and Gurugram for ensuing strict vigilance.
5. The Marshalls deputed by Delhi government may be trained and sensitized on issues concerning air pollution.
6. MCDs to seek technical expert opinion on effective scientific management of landfill sites.
7. All construction sites to be directed to prominently display dust control measures required to be taken as per MoEF&CC guidelines.
8. DPCC, transport department and Delhi police to finalise the policy for scrapping of old vehicles in consultation with MoRTH.
