Minutes of Review Meeting with Public Agencies & SPCBs to Discuss the Mitigation Measures for Control of Air Pollution in Delhi NCR 11 June 2019

A Review meeting with Public Agencies & SPCBs to discuss the Mitigation Measures for Control of Air Pollution in Delhi NCR was held on 11th June 2019. The meeting was chaired by Additional Director, AQM Division. The list of participants is annexed.

Additional Director, AQM Division, CPCB welcomed the participants and informed that CPCB has already communicated all the agencies to ensure mitigation measures and intensive ground level actions in Delhi NCR with special focus in identified areas in the meeting convened on May 27, 2019. The response of agencies is found to be highly inadequate in terms of ground level action in maintaining air quality within acceptable limits as per CPCB teams field inspection reports.

A brief presentation was made on Status of Delhi Air Quality and polluting sources in the identified areas observed by CPCB teams.

Agencies were asked to inform the actions taken against illegal dumping of garbage, C & D waste and road dust as reported in various sites during inspections. Additional Director, AQM Division, CPCB reiterated that agencies should check all the air polluting activities with special focus in identified areas and Hotspots in Delhi NCR and send the action taken reports daily to make ongoing 15-days interventions effective to tackle air pollution.

Head IT Division, also presented status of complaint redressal by various agencies. He requested all agencies for timely disposal of public grievances.

Actions to be ensured by all agencies based on above discussion are as follow: -

- 1. Agencies to take ground level actions to control air polluting sources especially road dust, open dumping/burning, industrial and vehicular emissions.
- 2. Submit action taken report to CPCB on aqm.cpcb@gov.in
- 3. Agencies should resolve all Social Media complaints at earliest.
- 4. Agencies to submit reports on mass awareness programmes carried out on World Environment Day.
