Minutes of Review Meeting with Construction Agencies and companies on Delhi NCR Air Quality September 30, 2019

A review meeting with the construction and development agencies to discuss the action plan to curb the air pollution from construction and demolition activities and road dust was held on September 30, 2019 at Central Pollution Control Board, Delhi. Meeting was chaired by Dr Prashant Gargava, Member Secretary, CPCB. The list of participants is annexed.

Member Secretary, CPCB welcomed the participants and emphasized that extensive efforts are to be made to deal with anticipated air pollution problem of winter season. He further stated that C&D activities and associated dust are among major contributors of air pollution in Delhi NCR region as per various studies and also feedback received through social media, Sameer app and CPCB team field visits.

It was informed that CPCB has developed guidelines for dust mitigation emanating from handling of construction material and C&D waste and also for sound environmental management of C&D waste in compliance to "The Construction & Demolition Waste Management Rules, 2016". It was also suggested that dust suppressants may be used at construction sites.

After deliberations, following actions were agreed:

- Construction agencies to share details of major ongoing projects with concerned SPCBs and CPCB by October 15, 2019
- Ensure proper implementation of guidelines on dust mitigation measures and sound environmental management of C&D waste, including deployment of adequate dust control measures.
- 3. Agencies to setup their own monitoring mechanism to ensure adequate measures to control air pollution.
- 4. SPCBs to have strict vigilance, take punitive actions against violators and submit weekly action taken reports to CPCB.
