Sir,

Direction under Section-5 of the Environment (Protection) Act, 1986 was issued to FETP Ankleshwar (M/s Narmada Clean Tech) vide CPCB letter dated 9.12. 2016 for improving performance of FETP and achieving compliance through improving compliance of inlet norms and operation and maintenance of FETP.

CPCB, vide letter dated 27.1.2017, requested GPCB to direct Notified Area Authority (NAA), Ankleshwar to submit a shortest possible time bound action plan for laying of over ground effluent conveyance system for FETP member industries in GIDC, Ankleshwar and to provide reports to CPCB on the action taken against defaulter units as and when reported by NCT. However, no reply has been received from GPCB so far.

M/s Narmada Clean Tech (NCT) has submitted interim reply to CPCB directions, vide letter dated 10.1.2017 and subsequent reply, vide letter dated 19.1.2017 (under intimation to GPCB), providing (i) list of specific locations identified in effluent carrying network of Ankleshwar Industrial Estate reporting high values of pH, COD and NH<sub>3</sub>-N along with surrounding industries and (ii) list of defaulting member industries.

Hence, GPCB is requested to take necessary action against the defaulting units as reported by NCT as well as to follow-up with NAA, Ankleshwar for laying of over ground effluent conveyance system for FETP member industries and submit the progress reports to CPCB on priority.
