Status of Air Quality in 05 Districts of Rajasthan *w.r.t.* Air Quality Index

Under National Ambient Air Quality Standards, 2009; 12 pollutants are notified based on short term & long term monitoring for Industrial/residential and Sensitive/ecological areas i.e. PM₁₀, PM_{2.5}, SO₂, NO₂, NH₃, Pb, O₃, CO, Ni, As, B(a)P & Benzene. Under National Air Monitoring Program (NAMP), a huge quantity of data generates annually for prescribed parameters i.e. PM₁₀, SO₂ and NO₂. CPCB evaluated the concept of Air quality Index (AQI) utilizing the data of Ambient Air Quality to ascertain the quality of air in terms of its probable impact on health and environment.

AQI is calculated for 03 parameters (PM₁₀, SO₂ and NO₂) monitored under NAMP. The calculated values are categorized in 06 pollution categories i.e. Good, Satisfactory, Moderate, Poor, Very Poor & Severe as reported in AQI document.

With the help of mapping softwares i.e. *Autocad Map, Mapinfo & ArcGIS*; yearwise maps of air quality level at stations are also prepared.

Under National Air Monitoring Program (NAMP) currently **21** Air Quality Monitoring Stations are operational in 05 districts of Rajasthan state. At each station annually **104** days Air Pollutants (PM₁₀, SO₂, NO₂) level is being monitored on 24 hourly basis.

The Air Quality Index is calculated for available monitoring data of **06** consecutive years (2010 to **May** 2015). Based on the index value, Air Quality is categorized as Good, Satisfactory, Moderate, Poor, Very Poor & Severe.

District **Alwar** has 03 NAMP stations established in industrial & residential area to monitor the air quality. Station no. 219 established in Matasya industrial area (MIA) at RIICO pump house has shown **Moderate** level of air pollution for last 5 years, however in year 2013 the air quality level was found to be of **Poor** Category.

Station no. 372 established in residential area at Regional Office of Rajasthan Pollution Control Board (RSPCB) has shown **Moderate** level of air pollution for last 5 years, however in year 2013 the air quality level found to be of **Poor** Category.

Station no. 373 established in industrial area at M/s Gourav Solvex Ltd has shown **Poor** category of air quality for last 3 yrs i.e. 2010, 2013 & 2014. Rest of the years the Air quality observed to be of **Moderate** level.

In **Jodhpur** district presently 06 NAMP stations are operational at residential & industrial area of city. At all the monitoring stations the air quality level found to be **Moderate** level, however in year 2015 Station no. 273 established at Sojati Gate shown **Poor** trend of air quality.

In **Udaipur** district, 03 NAMP stations are operational at residential & industrial area of city. Station no. 321 established in industrial area has shown **Moderate** level of Air quality for last 5 consecutive years i.e. 2010 to 2014. However, in year 2015 the air quality found to be **Poor** category. Station no. 320 & 294 established in residential area has shown **Satisfactory** to **Moderate** level of Air quality in last 6 years.

In **Kota** district, 03 NAMP stations are operational at industrial & residential area of city. At all the three monitoring stations the air quality found to be of **Moderate** level for last 6 years.

Jaipur, the capital city of Rajasthan has 06 operational NAMP stations covering the industrial & residential area of city. Here, at station no. 296 (PHED office, Ajmeri gate), 409 (Regional Office, RSPCB) & 297 (Vishvkarma Industrial Area) shown **Moderate** to **Poor** air quality trend for these 6 years.


At all monitoring stations the Air quality Index (AQI) is found to be in **Moderate** category which suggests that it may cause breathing discomfort to the people with lung disease such as asthma and discomfort to people with possibility of heart disease for Children and adults. At few stations of Alwar, Jodhpur & Jaipur the air quality index was found to be even in **Poor** category that means it may cause breathing discomfort to the people on prolonged exposure and discomfort to people with possibility of heart disease.

PM₁₀ is the prominent air pollutant at every NAMP stations of Rajasthan state. The worse quality found in year 2015 at few monitoring stations may be due to availability of **only 5 months data (upto May 2015)**. It may be possible that this quality may improve if the index calculated on the basis of annual average data.








