DIRECTIONS UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986 REGARDING INSTALLATION OF ON-LINE CONTINUOUS EFFLUENT MONITORING SYSTEM (OCEMS)-REG.

WHEREAS, the Ministry of Environment, Forest and Climate Change, Govt. of India, vide its notification S.O.157(E) dated 27.02.1996, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board (CPCB), to issue directions to any industry, Municipal Corporation, Municipal Council, Cantonment Board, any local or other Authority for the violation of emission and effluent standards notified under the Environment (Protection) Rules, 1986 and other standards and norms; and

WHEREAS, CPCB issued directions dated 5th February, 2014 under Section 18 (1) (b) of Water (Prevention & Control of Pollution) Act, 1974 to State Pollution Control Boards (SPCBs)/Pollution Control Committees (PCCs) of 11 Ganga River Basin States for installation of online continuous effluent monitoring systems (OCEMS) for parameters pH, BOD, TSS, COD and flow in Grossly Polluting Industries (GPIs); and

WHEREAS, it was clarified that flow meter & web camera may be installed in case of units with Zero Liquid Discharge (ZLD), CETP member units or units having effluent generation of <10 KLD; and

WHEREAS, CPCB issued directions dated 2nd March, 2015 under Section 18 (1) (b) of Water (Prevention & Control of Pollution) Act, 1974 to SPCBs /PCCs for granting extension of time up to 30th June, 2015 for installation of online continuous effluent monitoring systems (OCEMS); and

WHEREAS, CPCB vide letters dated 29th May, 2015 informed to all the SPCBs/PCCs that no further extension of time will be granted after June, 2015 and withdrawal of consent to operate along with forfeiture of bank guarantee of non-complying units will be the only option; and

WHEREAS, the GPIs need to follow the guidelines published by CPCB for OCEMS available on the link <https://cpcb.nic.in/upload/thrust-area/revised-GUIDELINES-final-sent-for-publication-on07.11.2014.pdf> and amended thereof; and

WHEREAS, CPCB updated inventory of GPIs in consultation with the concerned SPCBs during September, 2020 and 46 new units were identified as Grossly Polluting Industries (GPIs)

operating in the Ganga main stem states which require to install OCEMS as per CPCB guidelines; and

WHEREAS, 28 out of these 46 GPIs are yet to install OCEMS and connect it with CPCB server; and

WHEREAS, your unit (list enclosed) is also identified as one of the units which requires to ensure OCEMS data connectivity with concerned CPCB/SPCB server.

NOW, THEREFORE, in exercise of powers delegated under Section 5 of the Environment (Protection) Act, 1986, the unit is directed to comply with the following directions:

- 1) The unit shall install OCEMS system for the effluent discharge parameters namely pH, BOD, TSS, COD and flow as prescribed in the CPCB guidelines and provide connectivity of the same with CPCB and SPCB servers for 24 X 7 data transmission within three (3) months from the date of issue of the directions.
- 2) Action plan for installation and connectivity of OCEMS shall be submitted to CPCB within 15 days.
- 3) The unit shall submit documentary evidence of installation and connectivity of OCEMS for transmission of online 24 X 7 monitoring data to SPCBs/PCCs and CPCB servers.
- 4) In addition, the unit shall submit the details as per Annexure-I through
 - a) E-mail id- cems.cpcb@nic.in & ngrba.cpcb@nic.in
 - b) Uploading the data on the link provided on CPCB website (www. cpcb.nic.in) and
 - c) By speed post to the Member Secretary, Central Pollution Control Board.

In case of default in compliance with the above directions, CPCB will be constrained to initiate appropriate actions against the unit, without giving any further notice, in accordance with provisions of the Environment (Protection) Act, 1986.
