DIRECTIONS UNDER SECTION 18 (1) (b) OF THE WATER (PREVENTION AND CONTROL OF POLLUTION) ACT, 1974 REGARDING ANNUAL INSPECTION OF GROSSLY POLLUTING INDUSTRIES (GPIs) UNDER NAMAMI GANGE PROGRAMME

WHEREAS, the Central Board, has delegated powers vested under Section 18 (1) (b) of the Water (Prevention & Control of Pollution) Act 1974 to the Member Secretary, Central Pollution Control Board vide its resolution made in 196th Board meeting dated 29th March, 2022 to issue direction under Section 18 (1) (b) of the Water (Prevention & Control of Pollution) Act, 1974 to State Boards; and

WHEREAS, amongst others, under Section 17 of the Water (Prevention and Control of Pollution) Act, 1974, one of the functions of the State Pollution Control Board (SPCB), constituted under the Water (Prevention & Control of Pollution) Act, 1974 is to plan a comprehensive programme for prevention, control or abatement of pollution of streams and wells located in the State and to secure the execution thereof; and

WHEREAS, amongst others, under section 16 of the Water (Prevention and Control of Pollution) Act, 1974, one of the functions of the Central Pollution Control Board (CPCB), constituted under Water (Prevention and Control of Pollution) Act, 1974 is to coordinate activities of the State Pollution Control Boards and Pollution Control Committees (PCCs) and to provide technical assistance and guidance to SPCBs / PCCs; and

WHEREAS, Grossly Polluting Industries (GPIs) from sectors Chemical (Pharmaceuticals, Organic, Inorganic, Fertilizers, Refinery and Pesticides), Distillery, Sugar, Pulp & Paper, Textile, Dying, Bleaching, Slaughter House, Tannery, Food & Dairy and Others categories of industry located in states of Uttarakhand, Haryana, NCT-Delhi, Uttar Pradesh, Bihar, Jharkhand and West Bengal discharging effluent directly or indirectly into the river Ganga, Yamuna and their tributaries through drains, have potential to cause adverse effect on the river water quality; and

WHEREAS, it has been decided that inspection of GPIs should be made an annual exercise; and

WHEREAS, inspections of 3186 GPIs were carried out during February, 2023 - July, 2023 by teams of officials comprising of experts from Technical Institutions, concerned State Pollution Control Boards (SPCBs)/Pollution Control Committee (PCC), State Mission for Clean

Ganga (SMCGs)/District Ganga Committees (DGCs) and inspection reports were made available to concerned SPCBs/PCC by technical institutes for necessary action; and

WHEREAS, concerned SPCBs/PCC have taken action against GPIs which were found self-closed and non-complying during inspections; and

WHEREAS, CPCB issued direction dated 18.05.2023 under section 18 (1) b of the Water (Prevention and Control of Pollution) Act, 1974 to State Boards of Uttarakhand, Haryana, Delhi, Uttar Pradesh, Bihar, Jharkhand and West Bengal to take appropriate measures for compliance of following points in a time bound manner with immediate effect:

1. SPCB shall take appropriate action within 15 days of receipt of inspection report. Action to be uploaded on CPCB GPI portal (<https://cpcbinspection.co.in/gpi/>).
2. In case of by-pass of effluent/unauthorized operation/non-operational ETP/entry denied by industries, closure direction including levying environmental compensation shall be issued to these units. Such GPIs shall also be directed to submit the action plan to curb the pollution and adequacy assessment report of their effluent treatment plant (ETP) and same may be forwarded to CPCB within 30 days.
3. In case of non-compliance, SPCB shall issue directions (either show-cause notice for closure or closure) within 15 days of receipt of inspection reports. Further in case of Show Cause Notices, the unit shall be re-inspected and closure directions shall be issued in case of non-compliance within 30 days. Follow up inspections of show-cause notices shall be carried out by SPCB officials.
4. Follow up actions on Show cause notices to be completed within one month, including issuance of closure directions in case of non-compliance.
5. Closure directions shall be issued by SPCB to all temporary closed units except GPIs which are seasonally closed or have provided prior intimation of closure to concerned SPCB/CPCB. After consideration of re-opening request, unit shall be re-inspected by joint team consisting of technical institutes and SPCB.

AND WHEREAS, out of 1644 GPIs in Uttar Pradesh, 1013 were found complying, 221 non-complying and 410 self-closed; and

WHEREAS, as on 24.01.2024, actions in respect of 02 GPIs which were found non-complying and were issued show-cause notices and 19 GPIs which were found self-closed (list enclosed at Annexure-1) during annual inspections 2022-23 are pending at UPPCB level as per CPCB directions dated 18.05.2023;

AND WHEREAS, SPCBs are required to issue closure directions/direction not to resume operations till compliance verification to all self-closed GPIs; and

WHEREAS, SPCBs are required to verify the compliance status of GPIs which have been issued show-cause notices and take appropriate action including issuance of closure directions in case of non-compliance;

NOW, THEREFORE, in view of above observations and in exercise of the power conferred under section 18(1) (b) of the Water (Prevention and Control of Pollution) Act, 1974, you are hereby directed to take appropriate measures for compliance of following:

1. All GPIs which were reported as temporarily/permanently closed during annual inspections 2022-23 shall be issued closure directions with immediate effect. Closure of such GPIs shall be ensured through concerned District Magistrate and action taken report shall be forwarded to CPCB within 7 days.
2. All the non-complying GPIs which were issued show-cause notices and are pending for disposal, shall be issued appropriate directions on the basis of compliance status found during subsequent inspections, including issuance of closure directions in case of non-compliance within 7 days.

UPPCB shall acknowledge the receipt of the directions immediately and forward the action taken report to CPCB within 15 days of receipt of this direction.
