CIRCULAR

Subject : Filling up the vacant posts in the Central Pollution Control Board on deputation basis.

It is proposed to fill up the following vacant posts in the Central Pollution Control Board on deputation basis for a period of 03 years. The pay and allowances and other terms of deputation of the officers selected for the posts will be regulated in accordance with the instructions contained in the Department of Personnel & Training O.M No. 6/8/2009-Estt (Pay II), dated 17.06.2010 as amended from time to time. The eligibility criteria is as under :

1. Senior Law Officer : 01 Post on deputation basis in the PB-3; ₹ 15,600-39,100, Grade Pay ₹ 7600/-, Eligibility: (1) Officers of the Central Government/State Governments/Union Territory Admn./NCR or Central/State Autonomous or Statutory bodies: (a) (i) holding an analogous post on regular basis; or (ii) having at least five years of regular service in a post in the PB-3 ₹ 15,600-39,100/ with Grade Pay ₹ 6600/- or equivalent and (b) Possessing, (i) Bachelor's Degree in Law from a recognized University/Institute, and (ii) Should be a qualified legal practitioner i.e. Advocate within Advocates Act, 1961 who has not less than 8 years experience, out of which five years should be in a High Court/Supreme Court in handling environmental litigation cases **OR** Persons having not less than 8 years experience in rendering legal advice, preferably in matters relating to environmental pollution in a supervisory level

2. Law Officer : 02 Posts on deputation basis in the PB-3, ₹ 15,600-39,100, Grade Pay ₹ 6600/-, Eligibility, Officers of the Central Government/State Governments/Union Territory Administrations or Central/State Autonomous or Statutory bodies, (a) (i) holding analogous posts on regular basis; or (ii) having at least 5 years of regular service in posts in the PB-3, ₹ 15,600-39,100/- ; GP ₹ 5400/- or 8 years of regular service in posts in the PB-2, ₹ 9300-34800/-; GP ₹ 4600/- or equivalent; and (b) possessing; (i) Bachelor's degree in Law from a recognized University/Institution. (ii) Should be a qualified legal practitioner, i.e., Advocate (with the meaning of Advocate Act, 1961) who has practiced as such for not less than 8 years preferably in the cases relating to pollution control **OR** Bachelor's degree in Law in 1st class of a recognized University with not less than 8 years experience in rendering legal advice, preferably in matters relating to pollution control in a supervisory level.

Note:- Period of deputation shall not ordinarily exceed three years. The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. The maximum age limit for appointment by deputation should not be exceeding 56 years as on the closing date of receipt of application. The applications of the eligible and willing officers alongwith their bio-data (duly signed by the concerned officers) attested copies of ACR dossier for the last 5 years, Integrity Certificate, Vigilance Clearance and statement of Major/Minor penalties, if any, imposed during the last ten years may be forwarded. Applications which are incomplete, not through Proper Channel, without attested copies of ACR Dossier and other related documents will not be considered, the advance copy should invariably be followed the application through proper channel and must reach this Office not later than 15 days after the closing date, failing which their candidature will not be considered. Applications must be accompanied by the self attested copies of certificates of proof of age, educational qualifications, research/work experience and claim of belongings to SC/ST/OBC/Physically Handicapped, etc. failing to which the application will be treated as incomplete and summarily rejected.

General Conditions:-

1. Application should be sent either in English or in Hindi in the prescribed proforma only
2. Place of Posting : Anywhere in India
3. Only Indian Nationals need to apply.
4. The Board reserves the right not to fill up the post, if it so decides
5. No correspondence/representation will be entertained in regard to the call for interview and/or selection
6. The crucial date for determining the age-limit shall be the closing date for receipt of applications from the candidates in India.
7. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.

Prescribed application form along with recent passport size photographs, should reach **The Sr. Administrative Officer, Admn.(R), Central Pollution Control Board, "Parivesh Bhawan", East Arjun Nagar, Shahdara, Delhi-110032** within 45 days from the date of issue of this circular and last date for the Applicants from **abroad and Assam, Meghalaya, Arunachal Pradesh, Manipur, Mizoram, Nagaland, Tripura, Sikkim, Ladakh, division of J&K State, Lahaul and Spiti-District & Pangi Sub-division of Chamba district of Himachal Pradesh, the Andman & Nicobar Islands or Lakhsadeep**, will be 60 days or last date given in the Advertisement in the Employment News whichever is later. Incomplete applications will not be considered. The name of the post must be superscribed on the envelope.
