Registered Producers and Recyclers under the Hazardous and Other Wastes (Management & Transboundary Movement) Amendment Rules, 2022 are hereby informed that the timelines for filing quarterly and annual returns has been further extended from 30<sup>th</sup> June 2024 to 31<sup>st</sup> August 2024.

All the registered Producers and Recyclers on the Waste Tyre EPR Portal (URL: <https://www.eprtyrespcb.in>) shall continue to file their quarterly and annual return returns till 31<sup>st</sup> August 2024 for Financial Year 2023-24 During this period of extension till 31<sup>st</sup> August, 2024, Extended Producer Responsibility (EPR) Certificate generation & transfer will be carried out on EPR Portal.

The extension of time line for filing quarterly and annual returns for FY 2023-24 has been approved by MoEF & CC vide letter No. 12/136/2021-HSM dated 1st July, 2024 (Copy Enclosed)

**OFFICE MEMORANDUM**


**Subject: Extension of time line for filing of quarterly and annual returns till 31st August, 2024 under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 (EPR for Waste Tyre) - reg.**

This has reference to the letter dated 26<sup>th</sup> June, 2024 received from the Central Pollution Control Board (CPCB) stating that CPCB has received representations from Industry Association for extension of time period for filing of quarterly and annual returns under the under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 (EPR for Waste Tyre) as many of the recyclers are still to enter their production data for generation of EPR Certificate owing to various reasons such new to system, wrong entry needing editing/deletion and issues related to portal functioning.

2. CPCB further requested Ministry to extend time period for filling quarterly and annual returns till 31<sup>st</sup> August, 2024 for Financial Year (FY) 2023-24. During this period of extension till 31<sup>st</sup> August, 2024, Extended Producer Responsibility (EPR) Certificate generation and transfer will also be carried out on the EPR portal.

3. The matter has been examined in the Ministry and in accordance with the sub-paragraph (6) of paragraph 9 of Schedule IX of the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2024, Ministry hereby extends the time line for filing of quarterly and annual returns by the registered entities for FY 2023-24 till 31<sup>st</sup> August, 2024.
