**Water (Higher Range):** 1. Total Arsenic (As), 2. Cadmium (Cd), 3. Total Chromium (Cr), 4. Copper (Cu), 5. Iron (Fe), 6. Manganese (Mn), 7. Nickel (Ni), 8. Lead (Pb) & 9. Zinc (Zn)

**Soil:** Total Arsenic (As)

**B. Physicochemical Parameters:**

Total Dissolved Solids, Total Hardness, Chloride, Nitrate-N, Fluoride, Phosphate-P, Sodium, Conductivity, Chemical Oxygen Demand, Biochemical Oxygen Demand and Ammonia-N.
