All the registered entities on the E-Waste EPR Portal (URL: <https://www.eprtewastecpcb.in>) shall continue to file their quarterly and annual return till 31<sup>st</sup> January, 2025 for Financial Year 2023-24. During this period of extension till 31<sup>st</sup> January, 2025, Extended Producer Responsibility (EPR) Certificate generation & transfer will be carried out on EPR Portal.

The extension of timeline for filing quarterly and annual returns for FY 2023-24 has been approved by MoEF&CC vide letter No.12/136/2021-HSM dated 15<sup>th</sup> January, 2025 (Copy Enclosed).

**Subject: Extension of time line for filing of quarterly and annual returns till 31<sup>st</sup> January, 2025 under the E-Waste (Management) Rules, 2022- reg.**

This has reference to the letter dated 8<sup>th</sup> January, 2025 received from the Central Pollution Control Board (CPCB) stating that CPCB has received representations from Industry Association for extension of time period for filing of quarterly and annual returns under the E-Waste (Management) Rules, 2022 beyond 31<sup>st</sup> December, 2024.

2. CPCB has requested Ministry to extend time period for filling quarterly and annual returns till 31<sup>st</sup> January, 2025 for Financial Year (FY) 2023-24. During this period of extension till 31<sup>st</sup> January, 2025, Extended Producer Responsibility (EPR) Certificate generation and transfer will also be carried out on the EPR portal.

3. The matter has been examined in the Ministry and in accordance with the Rule 9A of the E-Waste (Management) Amendment Rules, 2024, Ministry hereby extends the time line for filing of annual and quarterly returns by the registered entities for FY 2023-24 till 31<sup>st</sup> January, 2025. No further extension will be given after 31<sup>st</sup> January, 2025 and CPCB may take action against non-complying entity as per the rules.
