**Sub: Extension of timelines for filing of annual returns and annual reports by stakeholders of the E-Waste (Management) Rules, 2016 – regarding**

1. The timelines for submission of annual returns and annual reports have been revised for the financial year 2019-20 by MoEF & CC vide OM dated 13.07.2020. The revised timelines are as follows:
  - Submission of annual returns in Form 3 by all stakeholders is extended from 30 June 2020 to 31 August 2020.
  - Submission of annual report with regard to implementation of the rules by SPCBs/PCCs to CPCB is extended from 30 September 2020 to 30 November 2020.
  - Submission of consolidated annual review report on management of e-waste by CPCB to the Ministry of Environment, Forest and Climate Change is extended from 30 December 2020 to 28 February 2021.


**Sub: Extension of timelines for filing of annual returns and annual reports by stakeholders of the E-waste (Management) Rules, 2016 - regarding.**
