ORDER

Revised Emission Standards for Gensets are notified by Ministry of Environment, Forest and Climate Change (MoEF&CC) in consultation with Central Pollution Control Board (CPCB) under Environment (Protection) Act, 1986 vide GSR 804(E.) dated 3-Nov-2022. As per notification, CPCB is the 'Nodal Agency' and mandated to ensure compliance of 'System and Procedure', coordinate activities related to Type Approvals, Conformity of Production (COP) Tests, settle disputes and resolve technical difficulties in execution of these rules.

In this context, it has been decided by CPCB to levy processing fee to the applicants with immediate effect for all the cases related to Type Approvals and Conformity of Production Tests (Failure, Extension, Exemption etc.). Details of the cases requiring fee(s) are as follows:


