OFFICE ORDER

Sub : Constitution of Two Member Committee on compliance of Hon'ble NGT Order dated 30.07.2018 in Vardhman Kaushik Vs UoI & Ors.

In compliance to the directions of the Hon'ble NGT dated 30.07.2018 in the matter of Vardhman Kaushik Vs UoI & Ors. (OA 21/2014) a two Member Committee with followings members is constituted:-

3. Shri N.B. Mazumdar, Ex- HUDCO, Head, Waste Management Division.
4. Dr. S.K. Tyagi, Ex-CPCB Scientist "E"

The Committee shall look into the followings:-

- (v) Evaluate list of violators by East Delhi Municipal Corporation (EDMC), who have not complied with the directions of the Hon'ble NGT in respect of open burning of plastics, leaves, garbage, etc. The person doing this act shall be liable to proceeded in accordance with the law with the help of Police, DPCC and Government of NCT to ensure that such activity is stopped;
- (vi) Any person & owner or builder is found to be violating any of the conditions stated in this order or non-compliance such person, owner, builder shall be liable to pay compensation of ₹ 50,000/-per default in respect of construction activity at site and ₹ 5000/- for each violation during collection and transportation of construction material, debris through trucks or other vehicles in terms of Section '15' of the NGT Act, 2010 on the "Principle of Polluter Pay ".
- (vii) The Committee shall undertake and list-out such cases & take steps for enforcement of orders of the Tribunal at par with the enforcement of direction under section 5 of the Environment (Protection) Act, 1986. If there is any other list of such violators, the same can also be furnished before the Committee.
- (viii) The Committee shall visit the landfill sites at Delhi and evaluate deterioration of ambient air & water due to municipal & plastics waste dumping.

Terms & Conditions:

- viii) The Committee shall be housed at the Office of **East Delhi Municipal Corporation (EDMC)**.
- ix) The Members of Committee shall be paid Rs. 5000/- per meeting in a day in the case number 24/2014, dated 20th April 2017 in the matter of Sameer Mehta Vs Union of India & Ors. All other contingent expenses shall be borne by EDMC.

- iii) The Committee shall interact with Commissioner, EDMC & concerned Sub-divisional Magistrate (SDM) to review pending cases with EDMC & SDMs and suggest course of action against the non-compliances
- iv) The Committee will issue directions to EDMC and SDMs to put-up the reasons for non-compliances.
- v) The Committee shall report & submit to the Hon'ble NGT for necessary direction against the non-compliances. A copy of the report shall be submitted to CPCB.
- vi) Any other direction issued by Hon'ble NGT in this matter, from time to time.
- vii) The expenditure may be met from the NGT fund (25%) available with CPCB on account of penalty imposed to industries as per the directions of Hon'ble NGT.
