**Subject: Directions under Section 3 of the Environment (Protection) Act, 1986 in respect of implementation of Notified Environmental Standards for Cement Industry- regarding**

Sir,

This is with respect to the implementation of environmental standards notified on 09/05/2016 by MoEF&CC for Cement Industries. A number of representations have been received from Cement Manufacturers Association and other Cement Industries regarding difficulties in compliance with the notified standards, besides request for the extension of time for the purpose. The matter has been reviewed and it has been decided that general extension shall not be granted and any extension regarding compliance with standards related to various parameters such as NO<sub>x</sub>, SO<sub>2</sub> and Particulate Matter etc. should be based on due assessment and submission of clear / specific road map for compliance with notified standards in a time bound manner.

It is, therefore, conveyed that CPCB may carry out assessment of each industry on case to case basis and obtain a clear and specific road map for compliance with each parameter which should be followed by issuance of directions under Section 5 of the Environment (Protection) Act, 1986 binding the industry to the implementation of the road map. The process may be completed at the earliest and the copy of directions may also be communicated to other regulatory authorities, State Pollution Control Board and other concerned Public Authority.
