

National Control Room established in CPCB to monitor Enforcement of SUP Ban

National Control Room to monitor effective implementation of SUP Ban has been established in CPCB in accordance with decisions taken by National Task Force in its third Meeting held on June 26, 2022. The Control Room, shall facilitate activities related to effective implementation of SUP ban including the following:

- (a) Provide assistance, guidance, clarification and information as may be sought by various stakeholders regarding ban on SUP items, which may include but not limited to the following:
 - Specific items covered under / excluded from SUP Ban.
 - Alternatives to banned SUP items and their availability in the respective State/UT.
 - Guidance for filing of Complaints on SUP Public Grievance App.
 - Guidance for operation of SUP Compliance Monitoring Portal
 - Issues related to switching over to Alternatives including Issue of Consent / Registration to Plastic producers (Consent Mechanism/ OCCMS/ Closure Notice/ Renewal).
 - Compostable plastic manufacturers: Certification procedure, testing facilities, certified compostable plastic manufacturers.
- (b) The National Control Room shall monitor enforcement of SUP ban through concerned State Authorities
- (c) Coordination of activities related to Awareness campaign on SUP

The Control Room shall be operational on all days between July 01-31, 2022 between 9.30 A.M to 6.00 P.M. The National Control Room team can be contacted at 01143102466 and queries related to SUP can be addressed to sup.cpcb@gov.in

CPCB has issued Directions to SPCBs/PCCs to set up Control Room on similar lines for effective implementation of SUP ban at State level. The State Boards are required to provide daily reports related to implementation of ban to CPCB. CPCB shall prepare the daily National level Compliance report on SUP ban based on the activities taken up by CPCB/SPCB/PCC.

The State Boards have further been directed to undertake comprehensive Awareness activities including Social media campaign, interactive meetings with industries, colleges, schools and other institutions on SUP. They have further been directed to intensify inspections of industrial & commercial establishment for effective implementation of the ban.

All States/UTs have been directed to ensure that complete information is provided on CPCB Compliance Monitoring Portal and SUP Public Grievance App for facilitation of enforcement and effective monitoring of implementation of SUP ban.
