Kind Attention: Producers, Recyclers, and Refurbishers under Battery Waste Management Rules, 2022

Subject: Guidelines for imposition of Environment compensation (EC) under Battery Waste Management Rules, 2022

Battery Waste Management (BWM) Rules, 2022 has been notified by Ministry of Environment Forest and Climate Change (MoEF&CC) on 22nd August, 2022. As per provision under Rule 13 (3) the BWM Rules, 2022, "The Central Pollution Control Board shall prepare and recommend guidelines for imposition and collection of Environmental Compensation from producers and entities involved in refurbishment and recycling of waste battery, in case of non-compliance of these rules. The Central Pollution Control Board may consult the Committee for Implementation constituted under rule 15. The recommended guidelines shall be submitted to the Ministry of Environment, Forest and Climate Change for concurrence."

The Central Pollution Control Board prepared the Environmental Compensation (EC) Guidelines in consultation with the stakeholders and the Guidelines were presented in the 3rd Implementation Committee meeting held on 2nd August, 2024. The Environmental Compensation (EC) Guidelines were submitted to the Ministry of Environment, Forest and Climate Change (MoEF&CC) vide letter dated 22nd August, 2024 for approval.

Accordingly, MoEF&CC vide letter dated 9th September, 2024 (Copy Enclosed) has provided concurrence on implementing the Environmental Compensation (EC) Guidelines. The approved EC Guidelines are enclosed herewith for ready reference.
