Sub: Directions under Section 5 of the Environment (Protection) Act, 1986 - reg.

WHEREAS, Dye & Dye Intermediate units are identified as one of the 17 categories of highly polluting industries which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

WHEREAS, Central Pollution Control Board, Regional Directorate, Vadodara inspected M/s Rohan Dyes & Intermediates, Plot No. 123, Phase I, GIDC Vatva, Ahmedabad-382445, Gujarat State on September 20, 2017 w.r.t offline status of Online Continuous Effluent monitoring System during the period of July 15 to August 15, 2017 to assess the compliance of the existing pollution control measures; and

WHEREAS, it was observed that the Unit discharges treated effluent to CETP. Treated effluent being discharged to CETP exceeds prescribed norms w.r.t TSS (116 > 100 mg/l); TDS (20078 > 2100 mg/l); COD (357 > 250 mg/l) & BOD (39 > 30 mg/l); and

WHEREAS, it was observed that the treated effluent was diluted with fresh water before discharging to CETP; and

WHEREAS, it was observed that the unit discharges treated effluent to CETP but has not installed Web camera; and

WHEREAS, it was observed that the used empty barrels of chemicals were found haphazardly dumped in open area; and

WHEREAS, the effluent discharged by unit to CETP in the Month of August (196.67 KLD) was more than the consented quantity (65 KLD); and

WHEREAS, on the basis of above stated observations Closure direction under Section 5 of Environment (Protection) Act 1986, was issued by Central Pollution Control Board on November 01, 2017 to the unit to close down all operational activities with immediate effect; and

WHEREAS, the Unit vide letter dated December 08, 2017 submitted the duly notarized undertaking, Treated effluent monitoring laboratory analysis report and requested to revoke the closure direction; and

WHEREAS, the Unit has informed vide Self certificate dated November 27, 2017 that the unit has stopped production since November 28, 2017 ; and

WHEREAS, the Unit has submitted an undertaking of December 07, 2017 that it has complied with all directions issued by CPCB and if plant is found non-compliant during verification by CPCB officials, the Unit will accept to close down operations immediately and shall not operate till full compliance is achieved; and

WHEREAS, it has been verified by the IT division of the CPCB on December 06, 2017 that the unit has provided the connectivity of the online monitoring system to the Central Pollution Control Board; and

WHEREAS, the Unit has submitted the requisite adequacy report of ETP on February 09, 2018; and

WHEREAS, CPCB constituted a Three-member committee vide office order dated 03.10.2017 having representative(s) from CPCB and MoEF&CC for examination and recommendation for revocation of the closure direction issued by CPCB; and

WHEREAS, the Three-member committee in its meeting held on April 17, 2018 examined the compliance report submitted by the Unit and recommended that the Unit may be allowed to resume operation with following conditions:


1. The unit shall submit performance audit report of Effluent Treatment Plant (ETP) from a Government Institute within 45 days of start of operation.
2. The unit shall submit ETP logbook details of each month to CPCB.


WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

NOW, THEREFORE, in exercise of powers vested to the Chairman, Central Pollution Control Board under Section 5 of the Environment (Protection) Act, 1986, and in view of notarized undertaking submitted by the unit under reference, the directions issued under Section 5 of the Environment (Protection) Act, 1986 to M/s Rohan Dyes & Intermediates, Plot No. 123, Phase I, GIDC Vatva, Ahmedabad-382445, Gujarat vide letter dated November 01, 2017 are hereby revoked with following conditions:

1. The unit shall submit performance audit report of Effluent Treatment Plant (ETP) from Government Institute within 45 days of start of operation.
2. The unit shall submit ETP logbook details of each month to CPCB.

The Unit will ensure compliance with the norms. In case of non-compliance by the Unit; action as deemed fit under the provisions of Environment (Protection) Act, 1986 shall be taken.


