Revoke Direction under Section 5 of the Environment (Protection) Act, 1986 –reg.

WHEREAS, the Textile, Dyeing & Bleaching industries are identified as one of the Grossly Polluting industries (GPIs) which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S.O. 157 (E) of 27.02.1996 and S.O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, CPCB issued direction dated 23.08.2017 under Section 5 of the Environmental (Protection) Act, 1986 to the M/s Annapurna Carpet Private Limited, Village-Tikara, Post-Kakahara, District- Mirzapur-221401, Uttar Pradesh, (herein after referred as the Unit) to close its operation immediately for non-compliance;

WHEREAS, the Unit reply vide letter dated 21.09.2017 was examined and following observations are made;

- i. The unit has stopped all the operations with effect from 19.09.2017 in compliance of the closure direction issued by CPCB.
- ii. The unit has submitted valid consents under Air and Water Acts with validity upto 31.12.2018 and submitted Hazardous waste Authorization is valid upto 2020.
- iii. The unit has submitted details of registration and connectivity of the OCEMS with the CPCB server which are confirmed by IT Division, CPCB.
- iv. The unit TDS was increased due to cotton dyeing where approx. 300 grams salts are added per Kg of dyeing. Now, the unit has stopped the cotton dyeing and run the plant mainly on woollen and polyester where such addition of salts is not required. After modification of chemical dosing the level of TDS is substantially reduced i. e. below 600 mg/l and the unit has guaranteed that, TDS will never increase from prescribed limit.

AND WHEREAS, CPCB constituted a Three-member committee vide office order dated 27.09.2017 having representative from CPCB, MoEF & CC and NMCG for examination and recommendation for revocation of the closure direction issued by CPCB; and

WHEREAS, the Three-member committee in its meeting held on 15.11.2017 examined the reply dated 21.09.2017 and recommended for revoke of closure direction dated 23.08.2017.

NOW THEREFORE, in view of the above observations and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act 1986, the closure direction dated 23.08.2017 is revoked and the unit M/s Annapurna Carpet Private Limited, Village-Tikara, Post-Kakahara, District- Mirjapur-221401, Uttar Pradesh is hereby directed to comply with the following directions;

1. The unit shall resume the manufacturing operation and informed immediately to CPCB; and
2. The Unit shall ensure all time compliance of the standards of treated effluent as per Gazette notification dated 10.10.2016 under Environment (Protection) Rules, 1986; and
3. The Unit shall submit the treated effluent analysis report by the laboratory recognized under the Environment (Protection) Act, 1986 within 30 days from the date of resumption of operation.

In case of failure of the unit to comply with the directions, action will be taken in accordance with the provisions under Environment (Protection) Act, 1986.
