Directions under Section 5 of the Environment (Protection) Act, 1986 –reg.

WHEREAS, the **Textile** industries are identified as one of the Grossly Polluting industries (GPIs) which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S.O. 157 (E) of 27.02.1996 and S.O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the CPCB issued direction dated 22.05.2017 under Section 5 of the Environmental (Protection) Act, 1986 to the M/s Deepak Dyeing House, BIDA Carpet City, Phase-1, Fulwaria, Bhadohi-221401, Uttar Pradesh, (herein after referred as the Unit) for compliance of following directions;

1. The unit shall not start any plant process without adequate Effluent Treatment Plant (ETP).
2. The unit shall not start any plant process without installing Online Continuous Effluent Monitoring System (OCEMS) with online connectivity to CPCB.
3. The unit shall not start any plant process without obtaining consent to operate from UPPCB.

AND WHEREAS, the Unit reply vide letters dated 08.08.2017 was examined and following observations are made;

1. The unit has stopped its operation w. r. t 17.06.2017 in compliance of closure direction issued by CPCB dated 22.05.2017.
2. The unit has submitted the Self-Certificate and Self- Declaration as per CPCB format.
3. The unit has valid consents under Air and Water Acts with validity upto 31.12.2017 and Hazardous Waste Authorization
4. The unit has connected the OCEMS with CPCB server and which is confirmed by IT division, CPCB.
5. The unit has upgraded the ETP system consists of screen chamber, oil and grease trap, equalization tank, tube settler, aeration tank, secondary chamber and Sludge Drying Beds (SDB). The unit has also installed filtration for sludge handling.

AND WHEREAS, CPCB constituted a Three-member committee vide office order dated 27.09.2017 having representative from CPCB, MoEF & CC and NMCG for examination and recommendation for revocation of the closure direction issued by CPCB; and

WHEREAS, the Three-member committee in its meeting held on 15.11.2017 examined the replies dated 08.08.2017 and recommended for revoke of closure direction dated 22.05.2017.

NOW THEREFORE, in view of the above observations and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act 1986, the closure direction dated 22.05.2017 is revoked and the unit M/s Deepak Dyeing House, BIDA Carpet City, Phase-1, Fulwaria, Bhadohi-221401, Uttar Pradesh is hereby directed to comply with the following directions;

1. The unit shall resume the manufacturing operation and inform immediately to CPCB; and
2. The Unit shall ensure all time compliance of the standards of treated effluent as per Gazette notification dated 10.10.2016 under Environment (Protection) Rules, 1986; and
3. The Unit shall submit the treated effluent analysis report by the laboratory recognized under the Environment (Protection) Act, 1986 within 30 days from the date of resumption of operation.

In case of failure of the unit to comply with the directions, action will be taken in accordance with the provisions under Environment (Protection) Act, 1986.
