**Directions under Section 5 of the Environment (Protection) Act, 1986**

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**WHEREAS**, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Air and Water, having potential to cause adverse effects on the water and air quality; and

**WHEREAS**, M/s Calico Trends, 15, Leather Complex, Industrial Area – Site-II, Unnao, Uttar Pradesh (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 03.04.2017 to verify the compliance status; and

**WHEREAS**, CPCB issued direction dated June 28<sup>th</sup>, 2017 under Section 5 of Environment (Protection) Act, 1986 for not complying with the prescribed discharge standard; and

**WHEREAS**, the unit's letter dated 07/07/2017, 25/07/2017, 31/07/2017 and 19/09/2017 were examined and following observations are made:

- i) The unit has submitted the self-certificate, undertaking and treated effluent analysis report to CPCB.
- ii) Improved the chemical dosing system to meet the prescribed norms.

**WHEREAS**, CPCB Constituted a Three-Member Committee vide office order dated 27/09/2017 having representative from CPCB, MoEF&CC & NMCG for examination and recommendation for revocation of the closure direction issued by CPCB; and

**WHEREAS**, The Three Member Committee in its meeting held on 21/11/17 examined the replies dated 07/07/2017, 25/07/2017, 31/07/2017 and 19/09/2017 and recommended for the revoke of the closure direction

**AND NOW, THEREFORE**, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment

(Protection) Act, 1986, the closure dated June 28<sup>th</sup>, 2017 issued to **M/s Calico Trends, 15, Leather Complex, Industrial Area – Site-II, Unnao, Uttar Pradesh** is hereby revoked and the unit is directed to comply the following directions:


1. The Unit, shall resume its manufacturing operation after obtaining valid consent under Water Act, 1974 and Air Act, 1981 from UPPCB.
2. The Unit shall submit treated effluent quality analysis report from recognised laboratory under the Environment (Protection) Act, 1986 within 30 days after resume of operation.
3. Unit shall maintain logbook of Hazardous waste sludge (Chromium sludge) disposal to TSDF and UPPCB shall monitor disposal of Hazardous waste sludge.
4. The Unit shall immediately inform to CPCB on resumption of manufacturing operation.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further action against the unit, in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.
