Directions under Section 5 of the Environment (Protection) Act, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Air and Water, having potential to cause adverse effects on the water and air quality; and

WHEREAS, M/s Raja Tannery, 81-C, Wajidpur, Jajmau, Kanpur, Uttar Pradesh (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 27/03/2017 to verify the compliance status; and

WHEREAS, CPCB issued direction dated June 12th, 2017 under Section 5 of Environment (Protection) Act, 1986 to the Unit for not complying with the prescribed discharge standard; and

WHEREAS, the unit replied vide letter dated 10/07/2017, 11/07/2017, 23/08/2017 and 06/09/2017 were examined and following observations are made:

- i) The unit has installed screens in effluent carrying drains and chambers.
- ii) Increased the dosing of alum into the chemical dosing system.
- iii) Increased the depth of settling tank.
- iv) The capacity of lifting pump from collection tank to settling tank has also been decreased.
- v) Provided copy of air and water consent valid till 31/12/2017 and copy of Authorization valid till 30/08/2022 issued by UPPCB under Hazardous Waste and Other Waste (Management & Transboundary Movement) Rules, 2016.
- vi) The unit has submitted the self-certificate, undertaking and treated effluent analysis report to CPCB.

AND WHEREAS, CPCB Constituted a Three-Member Committee vide office order dated 27/09/2017 having representative from CPCB, MoEF&CC & NMCG for examination and recommendation for revocation of the closure direction issued by CPCB; and

WHEREAS, The Three Member Committee in its meeting held on 21/11/17 examined the unit's replies dated 10/07/2017, 11/07/2017, 23/08/2017 and 06/09/2017 and recommended for the revoke of the closure direction.

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the closure direction dated June 12th, 2017 issued to **M/s Raja Tannery, 81-C, Wajidpur, Jajmau, Kanpur, Uttar Pradesh** is hereby revoked and the unit is directed to comply the following:

1. The Unit shall submit treated effluent quality analysis report from recognised laboratory under the Environment (Protection) Act, 1986 within 30 days after resume of operation.
2. Unit shall maintain logbook of Hazardous waste disposal to TSDF.
3. The Unit shall immediately inform to CPCB on resumption of manufacturing operation.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further action against the unit, in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.
