Sub.: Directions under Section 5 of the Environment (Protection) Act, 1986 - reg.

WHEREAS, Pesticide units are identified as one of the 17 categories of highly polluting industries which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality;

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed there under;

WHEREAS, Show Cause Notice under Section 5 of Environment (Protection) Act 1986, was issued on July 22, 2015 to all Pesticide units to show cause as to why the unit should not be closed down if, the unit has not complied fully with the directions issued w.r.t. installation of online emission & effluent monitoring system by June 30, 2015. Further it was directed to submit documentary evidence regarding status of installation and connectivity;

WHEREAS, the unit (M/s. Gujarat Insecticides Limited) was inspected by official of CPCB Regional Directorates, Vadodara on 22.03.2017 regarding on-line Continuous Effluent/Emission Monitoring System (OCEMS) under offline status of data connectivity and show cause notice issued to the unit dated May 22, 2017 on following observations;

- I. The unit (M/s. Gujarat Insecticides Limited), Ankleshwar was operating without valid consent (air & water) of Gujarat State pollution Control Board since 13.03.2017.
- II. The effluent sample collected at the ETP outlet w.r.t BOD (54 mg/l) > 30 mg/l) and COD (255 mg/l > 100 mg/l) are not meeting with the norms prescribed by GPCB.

WHEREAS, the unit has submitted Compliance against Show Cause Notice on 06.06.2017; and

WHEREAS, RD Vadodara inspected the unit on 22.06.2017 and observed that the effluent sample collected at the ETP outlet w.r.t BOD (63 mg/l > 30 mg/l) and COD (786 mg/l > 100 mg/l) are not meeting with the norms prescribed by GPCB and unit is a member of FETP but there was no discharge to GIDC drainage system to FETP (CETP) during the visit.

M/s. Gujarat Insecticides Limited

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

NOW, THEREFORE, in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986 **M/s. Gujarat Insecticides Limited**, Ankleshwar is directed to close down all operational activities with immediate effect in view of non-compliance observed during the inspection by CPCB.
