Sub: Directions under Section 5 of the Environment (Protection) Act, 1986 - Closure thereof

WHEREAS, the Textile industry is identified as one of the 17 categories of highly polluting industries in the country and have been discharging environmental pollutants directly or indirectly into the ambient water and air, which pose constant threat to cause adverse effect on the water and air quality; and


WHEREAS, M/s H. A. G Carpet (P) Ltd. (Dying Division) located in Industrial Estate of Dist. Mirjapur, UP was inspected by a team from from Regional Directorate (North), Lucknow on 21.03.2017 to verify the compliance of environmental standards. The inspecting team made the following observations:

1. That the unit was operating without consent under Air (prevention & Control of Pollution) Act, 1981 & Water Air (prevention & Control of Pollution) Act, 1974. However, it has applied for consent under Air & Water Acts only on 11.01.2017
2. That the unit was withdrawing raw water through bore well and not maintaining logbook to keep record of water consumption. The unit has also not obtained permission from CGWB for withdrawal of water.
3. That concentrations of Sulphide, Phenol, BOD & COD in treated effluent were observed as 16.4, 2.7, 126 & 370 mg/l respectively against the limit of 2.0, 1.0, 30 & 250 mg/l respectively for respective parameters. Thus the concentrations of all the parameters were found to be exceeding by about morethan 3 times of the notified standards except COD which was exceeding by 1.5 times.
4. That the unit has also not installed OCEMS and flow meter at the outlet of ETP.

WHEREAS, Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof.

NOW, THEREFORE, in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986, M/s H. A. G Carpet (P) Ltd. (Dying Division) located in Industrial Estate of Dist. Mirjapur, UP is hereby directed to close down its operation with immediate effect due to non-compliance of effluent standards & non installation of OCEMs as observed through para 3 & 4 above.
