Sub: Directions under Section 5 of the Environment (Protection) Act, 1986 -reg.

WHEREAS, the textile industries are identified as one of the Grossly Polluting Industries which have been discharging effluents directly or indirectly on land and into water, having potential threat to cause adverse effect on land and the ambient water quality; and

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed thereunder; and

WHEREAS, it is obligatory on the part of industries to install and operate Effluent Treatment plant (ETP) to comply with the effluent discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed thereunder and also to meet the consent conditions granted by State Pollution Control Board (SPCB)/ Pollution Control Committees (PCCs); and

WHEREAS, Hon'ble Supreme Court of India in the matter of Paryavaran Suraksha Samiti Vs Union of India & Others dated 22/02/2017 directed that no industry which requires "consent to operate" from the concerned Pollution Control Board, is permitted to function, unless it has a functional effluent treatment plant, which is capable to meet the prescribed norms for removing the pollutants from the effluent, before it is discharged; and

WHEREAS, a team of officers from the Central Pollution Control Board (CPCB), Delhi inspected the unit (herein after referred as the Unit) on May 16, 2018 to assess the adequacy of the existing pollution control measures; and

WHEREAS, the inspecting team found that the Unit was operational and observed that ETP of the unit was non-operational for a long period; and

WHEREAS, in view of the above and in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986, directions were issued to the unit vide letter no. B-29016/04/06/IPC-I/740 dated August 08, 2018 to remain closed and not to restart the operations until it complies with the following directions:

1. The Unit shall operate Effluent Treatment Plant properly so as to achieve the prescribed standards for effluent discharge.
2. The Unit shall not resume its operation till the above directions are complied and written permission is obtained from the CPCB.

WHEREAS, unit replied vide letter dated September 20 and 25, 2018, it is stated that no washing and dyeing was going on during visit of CPCB due to less demand of dye able yarns and fabrics from market and requested for revocation of closure direction; and

WHEREAS, unit (**M/s Goldtex Furnishing Industries, Kundli, Sonapat**) has submitted valid consent to operate up to September 30, 2019 and undertaking vide letter dated September 25, 2018 for compliance and mention as unit has stopped its operation w.e.f September 12, 2018 in compliance with CPCB direction; and

WHEREAS, CPCB constituted a Three-member committee vide office order dated 03.10.2017 having representative(s) from CPCB and MoEF&CC for examination and recommendation for revocation of the closure direction issued by CPCB; and

WHEREAS, the Three-member committee in its meeting held on 17.10.2018 examined the compliance report submitted by the Unit and recommended for revocation of closure direction with following conditions that:



- 1: The Unit shall submit performance assessment of the treatment system by analysis of treated effluent from a reputed Government Institution within 45 days from the resumption of its operation.

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof.

NOW, THEREFORE, in exercise of powers vested to the Chairman, Central Pollution Control Board under Section 5 of the Environment (Protection) Act, 1986, and in view of the compliance of above directions and the affidavit produced by the unit, the directions issued under Section 5 of the Environment (Protection) Act, 1986 to M/s Goldtex Furnishing Industries, Kundli, Sonapa Haryana vide letter dated August 08, 2018 is hereby revoked with following conditions:

1. The Unit shall submit performance assessment of the treatment system by analysis of treated effluent from a reputed Government Institution within 45 days from the resumption of its operation.
2. The Unit shall comply with the effluent & emission norms prescribed in the consent to operate issued by Haryana State Pollution Control Board under the Water Act, 1974 and the Air Act, 1981.

In case of non-compliance by the Unit action as deemed fit under the provisions of Environment (P) Act, 1986 shall be taken.
