DIRECTIONS UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the Textile, Dyeing & Bleaching industries have been identified as one the Grossly Polluting Industries (GPI) which have been discharging effluents directly or indirectly on land and into water, having potential threat to cause adverse effect on land and the ambient water quality; and

WHEREAS, M/s S.S. Textiles, (Formerly known as Jyoti Industries), E-72, Udyog Puram, Industrial Area, Partapur, Meerut, Uttar Pradesh (hereafter referred to as the 'Unit') is a textile industry; and

WHEREAS, CPCB issued direction on dated 06.12.2017 under section 5 of the Environment (Protection) Act, 1986 to the unit to comply with following directions:

1. The unit shall obtain valid consent to operate from the SPCB before resuming operation and shall start its operation only after obtaining valid consents under Water /Air Acts & authorization under the Hazardous & other Waste (Management Handling and Transboundary Movement) Rule, 2016.
2. The analysis result of the treated effluent shall also be submitted within 30 days through EPA recognised laboratories.
3. The unit shall submit the photograph of complete ETP with size & piping etc.
4. The unit shall report to CPCB immediately on resumption of operation.

AND WHEREAS, the unit till date did not reply of the above said directions; and

NOW, THEREFORE, in view of the above observations and exercising powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act, 1986, notice is hereby served to the Unit **M/s S.S.**

Textiles, (Formerly known as Jyoti Industries), E-72, Udyog Puram, Industrial Area, Partapur, Meerut, Uttar Pradesh to Show Cause why not the Unit should be closed down for not complying with revoke direction dated 30.10.2017 under Environment (Protection) Rules, 1986 and amendment thereof.

The reply to the Show Cause Notice shall be submitted to this office within 15 days from the date of this notice failing which suitable action as deemed fit under Environment (Protection) Act, 1986 will be initiated.
