Directions under Section 5 of the Environment (Protection) Act, 1986 –reg.

WHEREAS, Tannery industries are identified as one of the Grossly Polluting industries (GPIs) which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

WHEREAS, there is need to inculcate habit of self-monitoring within the industries for complying with the prescribed standards and this can be achieved by the methods like installing online effluent & emission monitoring devices; and

WHEREAS, it is obligatory on the part of industries to install effluent treatment plants (ETPs) to comply with the effluent discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed there under and also to meet the consent conditions granted by State Pollution Control Board (SPCBs) / Pollution Control Committees (PCCs); and

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, M/s Allied Leather Finishers Pvt. Ltd., F-27, 28, Site-II Industrial Area, Unnao (UP) (hereafter referred to as the 'Unit') is engaged in processing of wet blue to produce finished leather. The unit has own ETP for treatment of trade effluent.

WHEREAS, Central Pollution Control Board issued Show Cause Notice dated 05.11.2018, under Section 5 of the Environment (Protection) Act, 1986, to the unit to submit the copy of valid consent to operate in compliance with the CPCB directions dated 09.02.2018; and


WHEREAS, the unit vide letter dated 19.11.2018 submitted a copy of Consent to Operate under Water Act, 1974 and Air Act, 1981, Both consent to operate have validity up to 31.12.2019.


NOW THEREFORE, in view of the above observations and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act 1986, the requirements of Show Cause Notice dated 05.11.2018 are complied and **the unit M/s Allied Leather Finishers Pvt. Ltd., F-27, 28, Site-II Industrial Area, Unnao (UP)** is hereby directed to comply with the following direction:

- (i) The unit shall take necessary action to ensure that ETP treated effluent discharged by the unit will always comply the standards prescribed in the consent to operate.

In case of failure of the unit to comply with the directions, action will be taken in accordance with the provisions under the Environment (Protection) Act, 1986.
