Directions under Section 5 of the Environment (Protection) Act, 1986

WHEREAS, the **Textile (Dyeing and Bleaching)** industries are identified as one of the Grossly Polluting Industries OR 17 categories of highly polluting industries which have been discharging effluents directly or indirectly on land and into water, having potential threat to cause adverse effect on land and the ambient water quality; and

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed thereunder; and

WHEREAS, it is obligatory on the part of industries to install and operate Effluent Treatment plant (ETP) to comply with the effluent discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed thereunder and also to meet the consent conditions granted by State Pollution Control Board (SPCB)/ Pollution Control Committees (PCCs); and

WHEREAS, Hon'ble Supreme Court of India in the matter of Paryavaran Suraksha Samiti Vs Union of India & Others dated 22/02/2017 directed that no industry which requires "consent to operate" from the concerned Pollution Control Board, is permitted to function, unless it has a functional effluent treatment plant, which is capable to meet the prescribed norms for removing the pollutants from the effluent, before it is discharged; and

WHEREAS, a team of officers from the Central Pollution Control Board (CPCB), Delhi on inspected **M/s Jyoti Spinners, T-8, Industrial Area, Panipat, Haryana** (herein after referred as the Unit) on May 22, 2018 to assess the adequacy of the existing pollution control measures; and

WHEREAS, the inspecting team found the Unit operational and observed the following:

1. The unit was found non-complying w.r.t. treated effluent sample parameters i.e. **BOD: 200 mg/L (against norm 30 mg/L) and Oil & Grease: 21 mg/L (against the norms of 10 mg/l)**

It is evident from the above observations that the Unit is violating the prescribed effluent discharge standards notified under the Environment (Protection) Rules, 1986, and the discharge of untreated/partially treated effluent has all possibility to adverse impact the river water quality.

AND WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of

the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

NOW, THEREFORE, in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986, the following directions are being issued to the unit **M/s Jyoti Spinners, T-8, Industrial Area, Panipat, Haryana**


1. The Unit shall close all the plant operations with immediate effect and inform CPCB.
2. The Unit shall install adequate Effluent Treatment Plant and operate it properly so as to achieve prescribed standards for effluent discharge.
3. The Unit shall obtain permission from the Central Pollution Control Board before the resumption of plant operations.

In case of failure to comply with the said directions necessary action as deemed fit under the provision of the Environment (Protection) Act, 1986 will be taken by Central Pollution Control Board.
