**DIRECTION UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986**

**WHEREAS**, the Textile industries are identified as one of the Grossly Polluting Industries which have been discharging effluents directly or indirectly on land and into water, having potential threat to cause adverse effect on land and the ambient water quality; and

**WHEREAS**, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed there under; and

**WHEREAS**, it is obligatory on the part of industries to install and operate Effluent Treatment plant (ETP) to comply with the effluent discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed thereunder and also to meet the consent conditions granted by State Pollution Control Board (SPCB)/ Pollution Control Committees (PCCs); and

**WHEREAS**, the Ministry of Environment, Forest, & Climate Change, Govt. of India, vide notification S.O.157(E) of 27.02.1996 has delegated powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board (CPCB), to issue direction to any industry, Municipal Corporation, Municipal Council, Cantonment Board, to any local or other Authority for the violation of emission and effluent standards notified under the Environment (Protection) Rules, 1986 and other standards and norms; and

**WHEREAS**, M/s Chirag Textile, HUDA, Panipat, Haryana (*hereafter referred to as 'the Unit'*) is Textile industry and;

**WHEREAS**, the unit was inspected by a joint team of officials from CPCB & Haryana SPCB on 22.05.2018 to verify the compliance status. The joint team found the unit closed and entrance gate was locked during the visit.

**NOW, THEREFORE**, in view of the above and in exercise of the powers delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the **following directions are issued for compliance to M/s Chirag Textile, HUDA, Panipat, Haryana:**

Closure direction u/s 5 of Environment (Protection) Act, 1986 to M/s Chirag Textile, HUDA, Panipat, Haryana

1. The Unit shall remain closed till obtaining valid "consent to operate" under Water & Air Act (s) and Authorisation under Hazardous & other Waste Rules, 2016 from Haryana SPCB.
2. The Unit shall seek permission from CPCB before resumption of their manufacturing operations.

In case of default in compliance with the above directions, CPCB will be constrained to initiate appropriate actions against the Unit, without giving any further notice, in accordance with provisions of the Environment (Protection) Act, 1986.
