Sub: Directions under Section 5 of the Environment (Protection) Act, 1986 to M/s Goldtex Furnishing Industries, Village: Kundli, District - Sonapat - 131028, Haryana - Closure thereof.

WHEREAS, the textile dyeing processing industries are identified as one the Grossly Polluting Industries (GPIs) in the country which have been discharging pollutants directly or indirectly into ambient air and water, which pose constant threat to cause adverse effect on air and water quality; and

WHEREAS, the Central Government has notified standards for discharge of environmental pollutants from industries under the Environmental (Protection) Act, 1986 and rules framed there under; and

WHEREAS, holistic approach has been adopted to cover entire Ganga River Basin which cover the states of; Uttarakhand, Uttar Pradesh, Bihar, Delhi, and parts of Haryana, Himachal Pradesh, Rajasthan, Madhya Pradesh, Chhattisgarh, Jharkhand and West Bengal; and

WHEREAS, it is obligatory on the part of industries to install effluent treatment plants (ETPs) to comply with the effluent discharge standards as notified under the Environmental (Protection) Act, 1986 and rules framed there under and also meet the consent conditions granted by State Pollution Control Boards (SPCBs) / Pollution Control Committees (PCCs); and

WHEREAS, Hon'ble Supreme Court of India in the matter of Paryavaran Suraksha Samiti Vs Union of India & others dated 22/02/2017 directed that no industry which requires "consent to operate" from the concerned Pollution Control Board is permitted to function, unless it has a functional effluent treatment plant, which is capable to meet the prescribed norms for removing the pollutants from the effluent before it is discharged; and

WHEREAS, a team of officers from the Central Pollution Control Board (CPCB), Delhi inspected M/s Goldtex Furnishing Industries, Village: Kundli, District - Sonapat - 131028, Haryana (herein after referred as the Unit) on May 18, 2018 to assess the adequacy of the existing pollution control measures; and

WHEREAS, the inspecting team found the Unit operational and observed that the ETP of the Unit was non-operational for a long period.

WHEREAS, Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof.

NOW, THEREFORE, based on all facts and observations, in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986, **M/s. Goldtex Furnishing Industries, Village: Kundli, District - Sonapat - 131028, Haryana** is hereby directed to close all operation with immediate effect and not to restart the operations until it complies with the following directions:

1. The Unit shall operate Effluent Treatment Plant properly so as to achieve prescribed standards for effluent discharge.
2. The unit shall not resume its operation till to above directions are complied with and written permission is obtained from CPCB.

In case of failure to comply with the said directions necessary action as deemed fit under the provision of the Environment (Protection) Act, 1986 will be taken by Central Pollution Control Board.
