**Sub: Show Cause Notice (SCN) under section 5 of the Environment (Protection) Act, 1986.**

WHEREAS, MoEF&CC has notified emission standards for SO<sub>2</sub> and NO<sub>x</sub> for industrial boilers vide Gazette Notification No. G.S.R. 96 (E) dated 29.01.2018 in compliance of the direction issued by Hon'ble Supreme Court. The asbestos based industry using boiler shall adhere to emission norms for industrial boilers as per the said notification; and

WHEREAS, as per the directions of Chairman, Central Pollution Control Board, M/s Hilite Industries Pvt. Ltd., B-1, Bulandshaher Road, Ghaziabad, Uttar Pradesh, was inspected by CPCB team on 02.07.2018 to assess compliance status of above mentioned standards and found the unit closed due to its weekly off schedule. Subsequently, unit was re-inspected on 24.07.2018 and the inspecting team made following observations/recommendations:

- i. During stack emission monitoring, NO<sub>x</sub> emission (450 mg/Nm<sup>3</sup>) and SO<sub>2</sub> emission (632 mg/Nm<sup>3</sup>) were found exceeding the NO<sub>x</sub> and SO<sub>2</sub> standards for industrial boiler i.e. 300 mg/Nm<sup>3</sup> and 600 mg/Nm<sup>3</sup> respectively.
- ii. Unit should provide proper and safe stair case and monitoring platform and porthole for stack monitoring

WHEREAS, the Ministry of Environment, Forests & Climate Change, Government of India, vide Notification No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof;

Now, THEREFORE, in view of the above and exercising the powers delegated to the Chairman, Central Pollution Control Board, under section 5 of the Environment (Protection) Act, 1986, M/s Hilite Industries Pvt. Ltd., B-1, Bulandshaher Road, Ghaziabad, Uttar Pradesh, is hereby directed show cause as to why the unit should not be directed to close operation if necessary measures are not implemented to stop the violation of emission norm immediately and stack emission monitoring report from an Environment (Protection) Act recognized laboratory is not submitted as documentary evidence of compliance of emission norms within 15 days.

The industry shall submit reply & action taken report within 15 days from the date of issue of this Notice. In absence of the reply, it will be presumed that the industry has nothing to say in this regard and CPCB will be constrained to take action as deemed fit including prosecution under the provision of the Environment (Protection) Act, 1986.
