**Directions under Section 5 of the Environment (Protection) Act, 1986**

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**WHEREAS**, the tannery and leather industries are also identified as one of the 17 categories of highly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Air and Water, having potential to threat to cause adverse effects on the water and air quality; and

**WHEREAS**, M/s Top Tanners, 406/377-A, Gajjapurwa, Asharfabad, Jajmau, Kanpur, Uttar Pradesh (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 30<sup>th</sup> March, 2017 to verify the compliance status; and

**WHEREAS**, CPCB issued Show Cause Notice dated June 28<sup>th</sup>, 2017 under Section 5 of Environment (Protection) Act, 1986 to the unit for not having registered on CPCB portal and to install separate energy meter for PETP,

**WHEREAS**, the unit has replied vide letter dated July 13<sup>th</sup>, 2017 in respect of the directions that:

1. The unit has completed its registration with CPCB portal.
2. The unit has also installed Energy meter for PETP.

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under Section 5 of the Environment (Protection) Act, 1986, the Show Cause Notice dated June 28<sup>th</sup>, 2017 is hereby revoked and the unit **M/s Top Tanners, 406/377-A, Gajjapurwa, Asharfabad, Jajmau, Kanpur, Uttar Pradesh** is directed to comply with the following directions:

1. The unit shall ensure the proper operation of the ETP so as to achieve the prescribed standards and continuous transmission of data to CPCB server.

In case of non-compliance of the above directions, CPCB will be constrained to initiate appropriate action against the unit without giving any further notice in accordance with the provision of Environment (Protection) Act, 1986.
