DIRECTION UNDER SECTION '5' OF THE ENVIRONMENT (PROTECTION) ACT, 1986

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act,1986 and the rules framed there under; and

WHEREAS, the Ministry of Environment & Forests, Govt. of India, vide notification S.O.157(E) of 27.02.1996 has delegated powers vested under Section 5 of the Environment (Protection) Act,1986 (29 of 1986) to the Chairman, Central Pollution Control Board (CPCB), to issue direction to any industry, Municipal Corporation, Municipal Council, Cantonment Board to any local or other Authority for the violation of emission and effluent standards notified under the Environment (Protection) Rules,1986; and

WHEREAS, it is obligatory on the part of industries to install effluent treatment plants (ETPs) to comply with the effluent discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed thereunder and also to meet the consent conditions granted by State Pollution Control Board (SPCBs) / Pollution Control Committees (PCCs); and

WHEREAS, a direction under Section 5 of the Environment (Protection) Act,1986 was issued on 30th July,2015 to **M/s. Tayyaba International**, 1 D,14-A-1, Gajjapurwa, Jajmau, Kanpur, Uttar Pradesh for installation of online effluent monitoring system.

WHEREAS, M/s. **Tayyaba International**, 1 D, 14-A-1, Gajjapurwa, Jajmau, Kanpur, Uttar Pradesh. (hereinafter referred as 'the Unit') was inspected on 24.05.2017 by CPCB, RD, Lucknow. During the inspection the Unit was found closed.

NOW, THEREFORE, in view of the above, and exercising the powers delegated to the Chairman, Central Pollution Control Board (CPCB) under section 5 of the Environment (Protection) Act, 1986, the unit, M/s. **Tayyaba International**, 1 D,14-A-1, Gajjapurwa, Jajmau, Kanpur, Uttar Pradesh (hereinafter referred as 'the Unit') is hereby directed to

“remain close and not to carry out any industrial operations. In case of operations, unit shall install continuous online emissions/effluent monitoring system (OCEMS) with connectivity to UPPCB & CPCB servers and shall get valid consents from UPPCB”.

In case of default in compliance with the above directions, CPCB will be constrained to initiate action against the Unit, **M/s. Tayyaba International**, 1 D,14-A-1, Gajjupurwa, Jajmau, Kanpur, Uttar Pradesh in accordance with the provisions of the Environment (Protection) Act, 1986, without giving any further notice.
