Directions under Section 5 of the Environment (Protection) Act, 1986.

WHEREAS, Tannery industries are identified as one of the Grossly Polluting industries (GPIs) which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, M/s Taiyaba International, 1D, 14-A-1 Gajjupurwa, JAJMAU, Kanpur- 208010 (UP), (here in after referred as 'the Unit') is a tannery engaged in the processing of split leather to produce finished leather; and

WHEREAS, Central Pollution Control Board issued directions dated 24.09.2018 under Section 5 of the Environment (Protection) Act, 1986, to the unit to comply with the following:

1. The unit shall resume operation, for 60 days, only after obtaining valid consent from UPPCB.
2. The unit shall inform immediately to CPCB, on resumption of manufacturing operations.
3. The unit shall close down its operation on expiry of 60 days and shall seek permission from CPCB before resumption of manufacturing operations.
4. The unit shall submit treated effluent analysis report on weekly basis for one month.
5. The unit shall ensure uninterrupted data transmission to CPCB server.

AND WHEREAS, Central Pollution Control Board issued Show Cause Notice dated 04.01.2019 because unit did not respond to CPCB directions dated 24.09.2018 and not complied with the requirements of the directions,

(Contd.)

WHEREAS, Unit vide letter dated 12.01.2019 responded to CPCB direction dated 24.09.2018 informed that the unit could not operate, due to non-receipt of valid consent to operate from UPPCB and submitted the copy of application, sent to UPPCB to obtain Consent to Operate under Water Act, 1974.


NOW THEREFORE, in view of the above observations and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act 1986, Show Cause Notice dated 04.01.2019 is revoked and the unit, **M/s Taiyaba International, 1D, 14-A-1 Gajjupurwa, Jajmau, Kanpur- 208010 (UP)** is hereby directed to comply with the following directions:

1. The unit shall immediately inform to CPCB on resumption of manufacturing operation.
2. The unit shall comply with CPCB directions dated 24.09.2018 on resumption of operations.
3. The unit shall take necessary action to ensure that primary treated effluent discharged by the unit will always comply the PETP standards prescribed by UPPCB / inlet to CETP standards and ensure that PETP effluent is treated into the CETP.

In case of failure of the unit to comply with the directions, action will be taken in accordance with the provisions under the Environment (Protection) Act, 1986.
