DIRECTION UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed there under; and

WHEREAS, M/s Bliss Impex, Behrampur Road, Khandsa, Gurgaon, Haryana (hereinafter referred as 'the unit') is a Textile unit.

WHEREAS, the unit was inspected by a team of officials from CPCB on February 26, 2019 to verify the compliance of notification no. G.S.R. 1343(E), dated 29th January, 2018 regarding emission standards for industrial boilers (fuel wise) w.r.t. SO₂& NO_x parameters and following observations were made:

1. The unit was in operation.
2. The unit has valid Consent upto 30.09.2023 under Water & Air Act(s).
3. The unit is using coal as a fuel in its boiler.
4. During the inspection the team collected emission sample of SO₂& NO_x from the boiler stack emission and the analysis results showed value of Oxides of Nitrogen (NO_x) as **398 mg/Nm³** (against NO_x Std of 300mg/Nm³).

It is evident from the above observations that the unit is not complying with NO₂ emission norms as notified under E(P) Rule, 1986 for boiler stack emission.

WHEREAS, the Ministry of Environment & Forests, Govt. of India, vide notification S.O.157(E) of 27.02.1996 has delegated powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board (CPCB), to issue direction to any industry, Municipal Corporation, Municipal Council, Cantonment Board to any local or other Authority for the violation of emission and effluent standards notified under the Environment (Protection) Rules, 1986; and other standards and norms; and

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers delegated to the Chairman, CPCB under Section 5 of the Environment (Protection) Act, 1986,


notice is served herewith to Show Cause Why **M/s Bliss Impex, Behrampur Road, Khandsa, Gurgaon, Haryana should not be closed down** until all the necessary pollution control measures are planned and implemented so as to comply with the prescribed notified standards to the satisfaction of CPCB.


You are hereby given an opportunity to file your objections (if any) to the above proposed directions within 15 days from the receipt of this notice, failing which it will be presumed that you have nothing to say and appropriate action, in accordance with the provisions of the Environment (Protection) Act, 1986, will be taken against the unit without giving any further notice.
