**DIRECTION UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT, 1986-Revoked
thereof**

WHEREAS, the Central Government has notified standards for discharge of environmental pollutants from various categories of industries under Rule 3 of the Environment (Protection) Rules, 1986 and the rules framed there under; and

WHEREAS, the Ministry of Environment & Forests, Govt. of India, vide notification S.O.157(E) of 27.02.1996 has delegated powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board (CPCB), to issue direction to any industry, Municipal Corporation, Municipal Council, Cantonment Board to any local or other Authority for the violation of emission and effluent standards notified under the Environment (Protection) Rules, 1986; and

WHEREAS, it is obligatory on the part of industries to install effluent treatment plants (ETPs) and Air Pollution Control System to comply with the effluent & emission discharge standards as notified under the Environment (Protection) Act, 1986 and the Rules framed there under and also to meet the consent conditions granted by State Pollution Control Board (SPCBs) / Pollution Control Committees (PCCs); and

WHEREAS, in view of the above and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act, 1986, the unit vide letter no. B-536(T)/IPC-III/2019-20/566 dated 05.04.2019 was directed to close down their Textile Unit and not to resume their manufacturing operation till compliance of the following directions were issued to the unit:

1. The unit should carry out adequacy assessment report of ETP through reputed Government institutes such as IIT/NEERI & accordingly augment the ETP provided so as to achieve the prescribed discharge standards.
2. The unit shall report to CPCB regarding closure of manufacturing operations in compliance of the direction immediately on receipt of this direction.
3. The unit shall seek permission from CPCB before resumption of the manufacturing operations and submit compliance to CPCB immediately on receipt Closure Direction; and

WHEREAS, the unit has responded to the above said Closure Direction vide letter dated 13.06.2019 and informed to have complied with the directions; and

WHEREAS, CPCB constituted a three-member committee vide office order dated 03.10.2017 having representative(s) from CPCB and MoEF&CC for examination and recommendation for revocation of Closure Direction issued by CPCB; and

WHEREAS, the committee in its meeting held on 28.06.2019 reviewed the compliance made by the unit & verified the submitted supporting documents in line with the agreed criteria and recommended that the unit may be allowed to resume its manufacturing operation with certain conditions; and

NOW THEREFORE, in view of the compliance made by the unit to the direction issued by CPCB and in exercise of powers vested under Section 5 of the Environment (Protection) Act, 1986, the unit **M/s Chroma Processor, (Textile Dyeing) Village-Sewah Near Choutala Road, Panipat, Haryana** is allowed to resume its manufacturing operations subject to following conditions:

1. Submit performance assessment of the effluent treatment system including analysis of treated effluent by the same reputed government institute within 60 days.
2. Recommendations of the adequacy report be implemented within 60 days of start of operations.

In case of failure of the unit to comply with the above directions action as deemed appropriate will be taken with the provisions under Environment (Protection) Act, 1986.
