**Directions under Section 5 of the Environment (Protection) Act, 1986 –reg.**

**WHEREAS**, the Tannery industries are identified as one of the Grossly Polluting industries (GPIs) which have been discharging environmental pollutants directly or indirectly into the ambient air and water, having potential threat to cause adverse effect on the water and air quality; and

**WHEREAS**, there is need to inculcate habit of self monitoring within the industries for complying with the prescribed standards and this can be achieved by the methods like installing online effluent & emission monitoring devices; and

**WHEREAS**, it is obligatory on the part of industries to install effluent treatment plants (ETPs) to comply with the effluent discharge standards as notified under the Environment (Protection ) Act, 1986 and the Rules framed thereunder and also to meet the consent conditions granted by State Pollution Control Board (SPCBs) / Pollution Control Committees (PCCs); and

**WHEREAS**, M/s Superhouse Leather Limited (Sole Division) Tannery-3, B-16/17, Site-2, Industrial Area, Unnao, Uttar Pradesh (here in after referred as 'the Unit') is involved in the process of raw hides to finished leather; and

**WHEREAS**, the Unit was inspected by a team of officers from the CSIR-Central Leather Research Institute, Chennai on behalf of Central Pollution Control Board, Delhi on dated 31-03-2017 and observed that the unit was in operations without valid consent; and

**WHEREAS**, CBCB issued closure direction dated 22-06-2017, under Section 5 of the Environment (Protection) Act, 1986; to the Unit, for operating without valid consent; and

**WHEREAS**, the unit has submitted consent of the Water (Prevention & Control of Pollution Act 1974 and Air (Prevention & Control of Pollution Act) 1981, issued by Uttar Pradesh Pollution Control Board valid till 30-06-2017; and

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**NOW THEREFOR**, in view of the compliance by the unit for the consent to operate and in exercise of the powers delegated to the Chairman, Central Pollution Control Board under section 5 of the Environment (Protection) Act 1986, the closure direction dated 22-06-2017 is revoked and the unit M/s Super house Leather Limited (Sole Division) Tannery-3, B-16/17, Site-2, Industrial Area, Unnao, Uttar Pradesh is hereby directed to comply with the following directions-

- I. the Unit shall resume the manufacturing operations; and
- II. the Unit shall ensure all time compliance of the standards of treated effluent as per Gazette notification dated 01.01.2016 under Environment (Protection) Rules, 1986.

In case of failure of the unit to comply with the directions, action will be taken in accordance with the provisions under Environment (Protection) Act, 1986.
