Directions under Section 5 of the Environment (Protection) Act, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the tannery and leather industries are also identified as one of the 17 categories of highly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Air and Water, having potential to threat to cause adverse effects on the water and air quality; and

WHEREAS, M/s Baba Hide, 87/1, Mona Nagar, Wazidpur, Jajmau, Kanpur, Uttar Pradesh (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 24th March, 2017 to verify the compliance status; and

WHEREAS, CPCB issued Show Cause Notice dated June 12th, 2017 under Section 5 of Environment (Protection) Act, 1986 to the unit for having registered on CPCB portal,

WHEREAS, the unit has replied vide letter dated June 30th, 2017 in respect of the directions that:

1. The unit has connected its Online Continuous Effluent Monitoring System (OCEMS) with CPCB and has also completed its registration with CPCB portal.

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under Section 5 of the Environment (Protection) Act, 1986, the Show Cause Notice dated June 12th, 2017 are hereby revoked and the unit M/s **Baba Hide, 87/1, Mona Nagar, Wazidpur, Jajmau, Kanpur, Uttar Pradesh** is directed to comply with the following directions:

1. The unit shall ensure the proper operation of the PETP so as to meet the CETP norms as per the provision of Environment (Protection) Act, 1986.

In case of non-compliance of the above directions, CPCB will be constrained to initiate appropriate action against the unit without giving any further notice in accordance with the provision of Environment (Protection) Act, 1986.
