Revoke Directions under Section 5 of the Environment (Protection) Act, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Water and Air, having potential to threat to cause adverse effects on the water and air quality; and

WHEREAS, M/s Jama Corporation Pvt. Ltd ,Village Khalilpur, Akbarpur, Kanpur Dehat (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 27.04.2017 to verify the compliance status; and

WHEREAS, CPCB issued closure direction on dated July 4th, 2017 under Section 5 of Environment (Protection) Act, 1986 for not having valid consents under Water & Air Acts and not having authorization for disposal of hazardous waste ; and

WHEREAS, unit vide letters dt.20.07.2017, 04.08.2017, 22.08.2017 & 23.08.2017 submitted copies of the valid consents till 30.12.2018 under the Water and Air Acts and submitted authorization for disposal of hazardous waste with a validity for five years.

AND NOW, THEREFORE, in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the closure direction dated July 4th, 2017 is hereby revoked and the unit is directed to comply with the following.

The unit shall ensure proper operation of PETP so as to achieve the prescribed standards and continuous transmission of data to CPCB.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further stringent action against the unit (**M/s, Jama Corporation Pvt. Ltd., Village Khalilpur, Akbarpur, Kanpur Dehat**) in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.
