**Directions under Section 5 of the Environment (Protection) Act, 1986**

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**WHEREAS**, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Water and Air, having potential to threat to cause adverse effects on the water and air quality; and

**WHEREAS**, M/s M A Leather, 159/152, Jajmau, Kanpur (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 04.04.2017 to verify the compliance status; and

**WHEREAS**, CPCB issued show cause notice for closure dated July 17, 2017 under Section 5 of Environment (Protection) Act, 1986 to the unit; and

**WHEREAS**, unit vide letter dated 01.08.2017 submitted the details of registration of the OCEMS with the CPCB Industry Registration portal and provide the connectivity with CPCB server.

**AND NOW, THEREFORE,** in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the Show Cause Notice dated July 17<sup>th</sup>, 2017 is hereby revoked and the unit is directed to operate as per the consent conditions.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further stringent action against the unit (M/s M A Leather, 159/152, Jajmau, Kanpur), in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.


